Dear Mr. Lentzsch:

This is to advise that I am a member of a community which abuts the location which you have selected for your bus station, and the community is called Kirkwood. There is also several other communities around here, like Idlywild and the business people along 13<sup>th</sup> Street, etc. All of us object to the site you are selecting for many reasons too numerous to mention. There is prostitution and the selling of drugs in the area and has been for several years. We have all been trying to cope with that. The police department is there constantly. The State Legislature is trying to pass a law making repetitive arrests for prostitution a felony, thus sending the prostitutes to jail. As today, they are merely being bonded out on a misdemeanor and applying their trade again sometimes the very same day.

The prostitutes are opening doors and soliciting people who are stopped in that area. The businesses along this area of S. W. 13<sup>th</sup> Street are also opposed to the location. I have enclosed some of the names and petitions obtained from those who oppose the selection. There are continuous signatures being obtained and additional lists are being compiled and will be filed with the Clerk of the Commission in addition to the ones that we have enclosed. We are merely enclosing the names on these petitions to indicate to you that there is a lot of disgust with the selection for what it may bring into an already troubled area.

We met with the City Commission Monday, November 5, 2001 and discussed the possibility of the City working with you and your company to select another location, either in conjunction with RTS of Gainesville, as they attempted to do to begin with, at the Depot Street area. But since it had become delayed, your impatience caused you to attempt to select another site, and that is unfortunate, because the City would still like to work with you, and they will be contacting you in connection with finding another site, and also considering joining up with RTS for an intermodal transportation site, as you have announced in your information and issue sheet stated that you would like an intermodal site preferably.

We have nothing against Greyhound. They are doing a good service, but the location here

was one that just will not work in our opinion.

Secondly, the area is really too small. Those large buses will have to use our thinly paved street, S. W. 25<sup>th</sup> Place, for the big buses to maneuver, and there is just not enough room there. The road-bed cannot handle that weight, and that's only one of the many problems regarding the site.

Thirdly, it would create an immense traffic problem, as S. W. 13<sup>th</sup> Street is heavy traffic constantly, and there is no way with the present set-up that those buses can get in and turn around.

It seems the entire City Commissioners are in favor of your selecting another site. One of the County Commissioners, Penny Wheat, who lives in this area, has objected vociferously and is against the site and is actively making speeches before the City Commission as a spokesman for the people who are disagreeing with this site. I understand that she is going to attempt to get the County Commission to change the zoning in so far as the County is concerned. In addition to that, she has asked the Commission, and agreed to by all, to get the zoning changed along 13<sup>th</sup> Street.

Lastly, there is a large group of people working on the beautification of 13<sup>th</sup> Street. The City of Gainesville and Alachua County have been holding meetings with the over-all intent to establish a more vibrant, attractive, safe and inviting gateway, rich in healthy residents and thriving businesses, and to do that, they are attempting to eliminate the pornography sites, the prostitution activity, and the drug sales.

I wanted to let you know what is going on since you are not here, and not familiar with the situation, and would invite you to work with the City and all of the citizens in finding another site. There are several possible sites here with the proper zoning which you could use and the City will work with you in selecting those. There are sites which have a lot more room for the maneuvering of buses and to handle your bus traffic. For one, there is one on South Main Street, which would give you a direct route from I-75 to the site, and that is owned by Jim Stringfellow. If you would like to confer with Jim Stringfellow, whose large piece of property is for-sale on Main Street, the direct route to I-75, you may call him at (352) 332-7655. His FAX Number is (352) 332-4881, his cell phone is (352) 317-4626; and his home number is (352) 372-9988.

We would appreciate your consideration in this matter. We are not dictating nor demanding anything, we are merely trying to work with you to find a favorable site for all. This would satisfy all of the people in these up-scale neighborhoods who have signed the petition and who would like to see the bus site some other place.
