Beneficiary of NAIT, 1010 Waqf, Inc wrote in its By-Laws that— the real property (s) owned by 1010 Waqf, Inc (Sean M. McDermott, Assistant City Attorney I gave me copy of By-laws).

Mujeeb Cheema Executive Director, NAIT wrote in his e-mail to Timothy P. Hayes Deputy Fire Chief, Operations Division that The North American Islamic Trust (NAIT) is the owner-of-record ---.

Mujeeb Cheema Executive Director, NAIT wrote in other e-mail which Weaver, Stephen gave me instead of forwarding to me that The North American Islamic Trust (NAIT) holds title to real-estate located at 1010 West University Avenue, Gainesville, FL 32601("Property").---

Owner name on Permits issued (1991-2001) is Islamic Center.

Trespass Warning shows employer name ISLAMIC CENTER but its address is not the same as on web site of sunbiz.org (1760 state rd 207, ST AUGUSTINE, FL. 32084.

Muslim Student Association of Gainesville was not registered with UF on 9-25-1981 and 9-8-1982 with the address P.O.BOX 13051, University Station, Gainesville, Fl. 32604. The North American Islamic Trust, Inc, an Indiana not-for-profit corporation used the address in the Warranty Deed.

Islamic Community Center of Gainesville, Inc web site(<http://iccgfl.org>) indicates " Established in 1982 by a number of student".

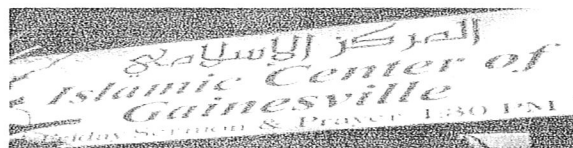



Draft of the letter

Dear

Please be advised that our office has been retained by numerous members of the Gainesville Muslim community who have great concerns about the status of the Islamic Center of Gainesville and how it is being run. This letter is being written in the hope to resolve certain issues that have arisen. The failure to satisfactorily resolve these issues will result in litigation being filed and a full investigation as to several areas of concern.

As you are well aware, the Islamic Center of Gainesville was initially organized by several Saudi students who took great pains to help establish a Masjid for the use of the local Muslim community. These students went to Saudi Arabia, raised a significant amount of capital, whereupon they came back to Gainesville and purchased the property located at 1010 West University Ave. This property along with a substantial amount of cash was given to the North American Islamic Trust Friends (NAIT) whose objective was to make sure that the institution and the funds would remain linked to the Islamic purpose for which they had been created. The Muslim Student Association (MSA) was founded at the University of Florida and made the beneficiary of these monies. Subsequently, the Gainesville Muslim community worked together to establish a new organization, the Islamic Center of Gainesville, to run the Masjid. The purpose of this was to allow community members, and not only students, to run the Masjid. The Islam on Campus (IOC) was subsequently registered as the Muslim Student Organization on campus.

In April of 2002, a new organization was established named 1010 Waqf Inc. This organization was established by just a few individuals who then In October 2006 re-registered MSA which was an inactive student organization at the time. It was re-registered without any real activities or purpose. The sole re-organization of MSA appears to be a design to allow 1010 Waqf board members to change the beneficiary status and the money in the Islamic center from MSA to 1010 Waqf. This was done without the knowledge nor the consent of the Muslim resident community or the Muslim student community of Gainesville. The hidden purpose of the re-organization of MSA appears clear as the MSA student organization disbanded and has not been registered since that time.

The structure and organization of 1010 Waqf is ambiguous to the Muslim community, the by-laws are not available and according to the members of 1010 Waqf, the board consists of five members who will continue to be members for life. There does not appear to be any voting procedure or policy in place to protect any funds previously raised and donated, and/or any future funds raised and donated by the Muslim community.

1010 Waqf has been running the Masjid with no transparency or accountability to the community. The by-laws of the 1010 Waqf remain secret and no community members

have access to them. Although repeatedly asked for open dialogue and an explanation of by-laws and procedures along with an accounting of funds, current board members of 1010 Waqf have repeatedly refused these requests.

Currently the Muslim members are preparing to file several different actions challenging the legal sufficiency of what is occurring. First and foremost there is an issue as to whether or not the transfer of control of the raised funds and the property by NAIT was fraudulently formed. Secondly, an evaluation and examination as to the purpose and the formation of MSA will have to be determined and an investigation through the University conducted. Certain actions will be requested for a full accounting of all proceeds that have been raised, as well as monies spent, including but not limited to any monies that have been spent on the physical structure or for any other purpose.

This entire situation has been extremely difficult for the members of the Muslim community. The Masjid is an extremely holy ground for those who have worked so hard to have it established in this community. The members feel very strongly that it is not only their right but their obligation to make sure that the original purpose of the Organization for the Islamic Center of Gainesville is honored. There needs to be a place in this community for any and all Muslims to be able to come together, honor their faith, and have a place that they can appropriately pay respect to their religion. This letter is written as a request for open dialogue and an opportunity for concerns and issues to be addressed. Please note that if these concerns and issues are not addressed, then numerous actions will be filed. A full internal investigation will be requested through the University as to the establishment of any MSA student organizations that were formed. Additionally, there will be discovery initiated to require an accounting as to all monies that have been collected under the purpose of a religious organization, and non compliance of the state guidelines for non-profit organizations.

It is the desire of my clients to re-establish the Islamic Center as a place where all Muslims can feel comfortable to worship, that the Masjid is provided the appropriate respect that it deserves, and be allowed to be run with the transparency and fairness that its original founders desired.

I appreciate your immediate attention to this matter.

This is brief history of the mosque and community demands. It was **bought in 1982 by two students from Saudi Arabia** who collected donation money for it. **They put the title under North America Islamic Trust (NAIT)**, Muslim Student Association (MSA) was the holder of beneficiary status. **The left over money** was put in an **investing account with NAIT**, MSA had access to the money, in 2002 one member of MSA transfer the account access to

1010 waqf Inc. five members (\$450,000.00). MSA with UF was replaced by Islam On Campus (IOC) in 2003. **In 2006, 1010 waqf registered a new and bogus MSA with only two students with UF** and this MSA wrote a letter to NAIT requesting the transfer of beneficiary status to 1010 waqf. NAIT thinking it was the original MSA transferred the beneficiary status to 1010waqf. The community was not consulted and did not approved it. The community wants **1010waqf dissolved or opened for election for its members** with limited terms.
