6 **An ordinance of the City of Gainesville, Florida; amending Chapter 8 of the**
7 **Code of Ordinances of the City of Gainesville relating to discrimination;**
8 **amending Section 8-3 and Section 8-24 to include the Airport Authority as a**
9 **person subject to the ordinance; providing directions to the codifier;**
10 **providing a severability clause; providing a repealing clause; and providing**
11 **an immediate effective date.**
12

13 **WHEREAS**, at least ten days notice has been given, once by publication in a newspaper
14 of general circulation notifying the public of this proposed ordinance, and of a public hearing in
15 the auditorium of City Hall in the City of Gainesville; and

16 **WHEREAS**, a public hearing was held pursuant to the published notice described, at
17 which hearing the parties and interests and all others had an opportunity to be, and were in fact,
18 heard.

19 **NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE**
20 **CITY OF GAINESVILLE, FLORIDA:**

21 **Section 1.** Section 8-3 of the Code of Ordinances of the City of Gainesville is amended to read
22 as follows:

24 **ARTICLE I. IN GENERAL**
25

26 **Sec. 8-3. "Person" defined.**
27

28 As used in this chapter, the term "person" includes one or more individuals, labor unions,
29 partnerships, associations, corporations, legal representatives, mutual companies, joint stock
30 companies, trusts, unincorporated organizations, trustees, trustees in cases under Title 11 U.S.C.,
31 receivers, and fiduciaries, and the Gainesville-Alachua County Regional Airport Authority.
32 Except as otherwise noted above, ~~the~~ term shall not include any federal, state or local
33 government or any agency thereof, but shall include all natural persons whether or not acting as
34 agents for such governmental entities.
35

36 **Section 2.** Section 8-24 of the Code of Ordinances of the City of Gainesville is amended to read
37 as follows:

3 **ARTICLE II. HUMAN RIGHTS BOARD**

4 **Sec. 8-24. Jurisdiction over governmental agencies.**

5
6 Other than as set forth in Section 8-3 of this ordinance, ~~the~~ human rights board
7 shall not have jurisdiction over the City of Gainesville or any other governmental entity,
8 their officers, employees or agents when the complaint of discrimination arises from
9 actions taken in their official capacity.


11 **Section 3.** It is the intention of the City Commission that the provisions of Sections 1 through 2
12 of this ordinance shall become and be made a part of the Code of Ordinances of the City of
13 Gainesville, Florida, and that the Sections and Paragraphs of this ordinance may be renumbered
14 or relettered in order to accomplish such intentions.
15

16 **Section 4.** If any section, sentence, clause or phase of this ordinance is held to be invalid or
17 unconstitutional by any court of competent jurisdiction, then said holding in no way affects the
18 validity of the remaining portions of this ordinance.
19

20 **Section 5.** All ordinances, or parts of ordinance, in conflict herewith are to the extent of such
21 conflict hereby repealed.


23 **Section 6.** This ordinance shall take effect immediately upon its adoption.
