20	Section 1. Reestablishment of Fund. There is hereby re-established the perpetual care			
21	trust fund known as the Thomas Center Endowment Trust Fund for purposes of receiving funds			
22	for the sole use and benefit of the City owned Thomas Center located in the City of Gainesville.			
23	Section 2. Trustees. The members of the Gainesville City Commission, ex officio,			
24	shall be the trustees of the Thomas Center Endowment Trust Fund, and said Trustees shall have			
25	the exclusive jurisdiction and control as to all matters in connection with such Fund, which Fund,			
26	under policies and direction made by said Trustees, shall be administered by the City Manager.			

1	Section 3. Corpus. The assets of the Thomas Center Endowment Trust Fund shan be			
2	used only for the Thomas Center owned by the City of Gainesville and for no other purpose. The			
3	City Commission shall invest Fund assets in accordance with the City's investment policy.			
4	The Thomas Center Endowment Trust Fund may receive public and private gifts, and			
5	may make investment of such funds as authorized by the Trustees. Estimated revenues and			
6	expenditure of the fund shall be included in the annual budget of the City of Gainesville.			
7	Expenditures made from the fund will be in accordance with the adopted budget.			
8	All funds in the Thomas Center Endowment Trust Fund as of the effective date of this			
9	Resolution, and all private funds previously donated to the City of Gainesville for use at the			
10	Thomas Center heretofore used for such purpose, are hereby set aside and transferred to the			
11	Thomas Center Endowment Trust Fund. All donations designated for such purpose that are			
12	hereafter made to the City shall be placed in the Fund as soon as practical.			
13	Section 4. Audit. The assets of the Thomas Center Endowment Trust fund shall be
