Hundreds of low income residents were asked to answer a carefully designed survey about civil legal needs. Surveys were also sent by email to lawyers, judges and social services agencies. Survey data was then compiled and the TRI-S Board of Directors adjusted the TRI-S priorities according to the needs assessment results
			In 2020, TRLS closed a total of 3,453 cases for all 17 counties served by the program. More than a third of those cases (35.4%) were Alachua County residents and of those Alachua County cases, more than a third (34.4%) were housing cases.
			Two TRLS attorneys, a Senior Staff Attorney and a Managing Attorney, will be specifically assigned to work on the Project.
