APPEAL FOR IMMEDIATE ENFORCEMENT OF RESOLUTION R-82-35 RELATING TO THE CITY OF GAINESVILLE AGREEING TO MAINTAIN THE STREETS OF KIRKWOOD SUBDIVISION TO THE EXTENT NECESSARY TO PROTECT THE PUBLIC HEALTH, SAFETY AND WELFARE.

On behalf of the residents of Kirkwood, we are requesting compliance with the City Commission Resolution R-82-35 passed on April 12, 1982 (copy attached). This Resolution assured street maintenance at the level "necessary to protect the public health, safety and welfare." However, road maintenance has been neglected since the Fall of 1997/Spring 1998, although requests have been made for resumption of road maintenance.

On April 21, the current Chairman/President of KEIA, Inc. (the neighborhood association which holds the deeds to the roads) asked for a written response from the City as to what statutes, ordinances, or resolutions since 1982 make the Resolution null and void. We would like a written response to this request. To our knowledge, no communication or action by the City Commission, independently or in interaction with KEIA, Inc. is of a nature to supercede the 1982 Resolution.

At this juncture, communication within and between the City and KEIA, Inc. has become so muddled (deficient and confusing) that both organizations need more time to explore alternative solutions and their long term consequences.

It is imperative that the accelerating deterioration of the streets be stopped now, while both parties devote themselves to a higher level of trust, cooperation, and communication.

RESOLUTION R-82-35 PASSED April 12, 1982

A RESOLUTION RELATING TO THE CITY OF GAINESVILLE AGREEING TO MAINTAIN THE STREETS OF KIRKWOOD SUBDIVISION TO THE EXTENT NECESSARY TO PROTECT THE PUBLIC HEALTH, SAFETY AND WELFARE

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FLORIDA:

Section 1. That upon receiving evidence that the owner of such streets has no objection, the City of Gainesville shall maintain the streets in the Kirkwood Subdivision to the extent necessary to protect the public health, safety and welfare.

This Resolution shall become effective Section 2. immediately upon its adoption.
