approve the staff recommendation and additional direction from the City Commission as follows: *STAFF RECOMMENDATION: Direct staff to draft a letter for the Mayor's signature to urge the USEPA to: 1) Complete off-site soil delineation & remediation as soon as possible; 2) complete Consent Decree and implement the Record of Decision (ROD) as soon as possible; 3) expedite indoor dust evaluation; 4) if indoor dust and/or health surveys indicate site-related problems- EPA should take appropriate action; 5) direct LIT technical team to stay engaged in remedial design, on-going monitoring, indoor dust study, etc.; 6) direct LIT technical team to provide periodic updates to the City and County Commission; 7) provide further direction to staff as appropriate. ADDITIONAL CITY COMMISSION DIRECTION: 1)Resend the previous correspondence to the Gainesville Alachua County Association of Realtors regarding obligations to disclose anything that diminishes the value of Real Estate; 2) Stress ongoing access to documents from EPA to both the LIT and Protect Gainesville Citizens; 3) contract the Property Appraiser regarding property re-assessment; 4)direct the City Manager to look into both the feasibility of possible funding of a blight study in the area surrounding the site for the purposes of forming a CRA; 5) develop a plan to contact the property owners with the intent of encouraging them to do off site soil remediation; 6) ask EPA to continue periodic updates or meetings with the residents; 7) direct the City Attorney to work with the environmental counsel to pursue cost recovery.*
