5	of the City of Gainesville Reserve Area pursuant to Chapter 90-496,				
6	Special Act, Laws of Florida, as amended by Chapter 91-382 and				
7	Chapter 93-347, Special Acts, Laws of Florida, known as the Alachua				
8	County Boundary Adjustment Act; making certain findings; including				
9	within the corporate limits of the City of Gainesville, Florida, that

22	WHEREAS, Chapter 90-496, Special Act, Laws of Florida, as amended by Chapter 91-382				
23	and Chapter 93-347, Special Acts, Laws of Florida, created the "Alachua County Boundary				
.4	Adjustment Act" (hereinafter collectively referred to as "the Act") which sets forth procedures for				
25	the annexation of contiguous, compact, unincorporated territory within a municipality's reserve				
26	area; and				
:7	WHEREAS, on January 10, 2006, the Board of County Commissioners of Alachua County				
8	designated the Reserve Area for the City of Gainesville pursuant to the Act; and				

1.	WHEREAS, on September 11, 2006, the City Commission voted to accept the Petition for			
2	Voluntary Annexation, submitted by the City as the owner of the real property described herein and			
3	determined that the Petition bore the signatures of the owner of the property; and			
4	WHEREAS, on February 12, 2007, the City Commission of the City of Gainesville			
5	adopted Ordinance No. 060300, which adopted the Urban Services Report setting forth the plans			
6	provide urban services to that portion of the Reserve Area proposed to be annexed in accordance			
7	with the procedures provided in the Act; and			
8	WHEREAS, a copy of the Urban Services Report was filed with the Alachua County			
9	Board of County Commissioners; and			
10	WHEREAS, the City of Gainesville desires to annex a certain portion of its Reserve Area			
11	which is compact and contiguous to the present corporate limits of the City; and			
12	WHEREAS, pursuant to law, notice of adoption of this ordinance was published for two			
13	consecutive weeks prior to first reading in a newspaper of general circulation notifying the public of			
14	the Public Hearing of this proposed Ordinance to be held in the City Commission meeting room,			
15	First Floor, City Hall, in the City of Gainesville; and			
16	WHEREAS, Public Hearings were held pursuant to the published notice described above at			
17	which the parties in interest and all others had an opportunity to be and were, in fact, heard.			
18	NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE			
19	CITY OF GAINESVILLE, FLORIDA:

1	Section 1. The City Commission finds that the Area described in Section 2 of this			
2	Ordinance (hereinafter referred to as the "Area"), though separated from the city limits by the			
3	presence of a publicly owned county park, is reasonably compact and contiguous to the present			
4	corporate limits of the City of Gainesville. The City Commission further finds that the presence of			
5	this publicly owned county park does not prevent the inhabitants from fully associating and trading			
6	with each other, socially and economically, and that no part of the Area is within the boundary of			
7	another municipality or county. The City Commission finds the Area to be within its Reserve Area			
8	and the annexation does not create an enclave.			
9	Section 2. The following described Area is annexed and incorporated within the corporate			
10	limits of the City of Gainesville, Florida:			
11 12	See Legal Description attached hereto as Exhibit "A", and made a part hereof as if set forth in full.			
13 14	Section 3. The corporate limits of the City of Gainesville, Florida, as set forth in Appendix			
15	I, Charter Laws of the City of Gainesville, are amended and revised to include the Area described in			
16	Section 2 within the corporate limits of the City of Gainesville, Florida.			
17	Section 4. The City Manager is authorized and directed to make the necessary change in			
18	the Code of Ordinances of the City of Gainesville, Florida, to comply with this ordinance.			
19	Section 5. In accordance with Section 171.062, Florida Statutes, the Alachua County land			
20	use plan and zoning or subdivision regulations shall remain in full force and effect in the Area			
21	described in Section 2 of this Ordinance until the City adopts a comprehensive plan amendment			


1	that includes the annexed area. The Gainesville Code Enforcement Board and code enforcement			
2 .	officers shall have jurisdiction to enforce these regulations during the interim period through the			
3	Gainesville Code Enforcement Board process as described in Division 8 of Article V of Chapter			
4	of the Code of Ordinances of the City of Gainesville and the Civil Citation Process, as described in			
5	Division 6 of Article V of Chapter 2 of said Code. During the interim period, the City may rezone			
6	properties in the annexed area to an Alachua County Zoning classification/category that conforms			
7	with the Alachua County Comprehensive Plan.			
8	Section 6. If any portion of this Ordinance is declared by a court of competent jurisdiction			
9	to be invalid or unenforceable, such declaration shall not be deemed to affect the remaining			
0	portions of this Ordinance.			
1	Section 7. The Clerk of the Commission is directed to submit a certified copy of this			
2	Ordinance to: 1) the Executive Office of the Governor; 2) the Florida Department of State; and 3			
3	the Clerk of the Circuit Court of the Eighth Judicial Circuit in and for Alachua County, Florida.			
4	Section 8. This Ordinance shall become effective immediately upon adoption.
