

**RESOLUTION NO. 180393**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FLORIDA, RECOMMENDING APPROVAL OF BIOMONDE AS A QUALIFIED TARGET INDUSTRY BUSINESS; AGREEING TO BUDGET AND APPROPRIATE UP TO SIXTEEN THOUSAND TWO HUNDRED DOLLARS (\$16,200) AS LOCAL FINANCIAL SUPPORT IN THE QUALIFIED TARGET INDUSTRY TAX REFUND PROGRAM; PROVIDING AN IMMEDIATE EFFECTIVE DATE.**

**WHEREAS**, the business under consideration, BioMonde is a life sciences/health company providing wound care services to the European and US market; and

**WHEREAS**, BioMonde, is located in a local Enterprise Zone within the City of Gainesville, Alachua County, Florida at the Innovation Hub, 747 SW 2<sup>nd</sup> Avenue, Suite 240; and

**WHEREAS**, BioMonde, in its current site, will employ 18 employees and is anticipated to begin hiring in Fiscal Year 2016 with an average annual compensation of \$52,500 per year; and

**WHEREAS**, Enterprise Florida, Inc. represents that the average private sector annual wage in Alachua County, Florida is \$34,918; and

**WHEREAS**, BioMonde intends to make a capital investment of \$824,538 over the next five years; and

**WHEREAS**, BiMonde, has applied for the Qualified Target Industry Tax Refund for an Enterprise Zone location, pursuant to Section 288.106(3), Florida Statutes; and

**WHEREAS**, the project is in the High Impact Sector and the City of Gainesville is providing the required local financial support to receive the High Impact Performance Incentive Grant (HIPI) bonus; and,

**WHEREAS**, the request by BioMonde, has been reviewed by Enterprise Florida's primary economic development partner in Gainesville/Alachua County, the Gainesville/Alachua County Council for Economic Outreach and Gainesville Area Chamber of Commerce; and

**WHEREAS**, on August 28, 2018, the Alachua County Board of County Commissioners approved funding 50% of the local financial support (\$16,200) towards this project via an adopted and amended Resolution; and,

**WHEREAS**, the Gainesville City Commission finds that the expenditure of City funds as local financial support for BioMonde, constitutes a valid public purpose.

**WHEREAS**, in January, 2014, the City Commission passed Resolution No. 130608 approving BioMonde as a Qualified Target Industry business; and,

**WHEREAS**, the City Commission wishes to alter the eligibility period and intends this Resolution to replace Resolution 130608 and therefore repeals Resolution No. 130608 upon the effective date of the Resolution.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FL:**

1. That the Commission finds, determines, and declares that the recitals in the preamble are true and correct, and hereby incorporates them by reference.
2. That in accordance with Section 288.106(4)(a)(10), Florida Statutes, the City Commission recommends that BioMonde, be approved as a Qualified Target Industry (QTI) Business.
3. That the City of Gainesville has calculated that this project's average annual wage of \$52,500 is more than 150% of Alachua County's average private sector annual wage as determined by Enterprise Florida.
4. That the City agrees to budget and appropriate up to \$16,200 as local financial support over a seven year period commencing in Fiscal Year 16 and running through Fiscal Year 23 to the Florida Economic Development Trust Fund in the event BioMonde is certified as a QTI Business and locates its business within the City of Gainesville corporate limits and specifically within the City's established Enterprise Zone. The budgeted amount includes both the Qualified Target Industry Tax Refund and the High-Impact Sector Refund.
5. This resolution shall take effect immediately upon its adoption.
