This memorandum serves to provide a report on the City's efforts to increase the number of residents receiving food stamps; and the City and County activities to increase access to food stamps for residents. In accordance with the Florida Department of Children and Families (DCF) website:

The ACCESS Florida Program is responsible for public assistance eligibility determination and ongoing case management of Food Stamps. The Food Stamp Program helps low-income individuals and families buy the food they need for good health. Income and asset limits vary based on the eligibility category. ACCESS Florida is the service delivery model for economic self-sufficiency services. It is based on streamlined workflows, policy simplification and technology innovations. ACCESS Florida provides enhanced access to services through a combination of Department staff and community providers. Recognized as a national model, this service delivery system offers eligible clients a self-directed path to economic services seven days a week, 24-hours a day through a web application and an integrated voice response system. This system makes it easier and faster for clients and potential clients to apply and access information about their accounts. DCF was recognized in 2009 for excellence in service to those facing economic crisis. The USDA awarded the state of Florida a \$7,179,612 bonus for achieving the best payment accuracy rate in the country for food stamp program benefits.

In an effort to provide improved access to services for their customers, DCF has developed and are looking for community participants to work with mutual customers in a "multiple access" approach to self-sufficiency. This assists DCF to maximize shared resources to help increase customer access to services needed to strengthen families in the local community by providing different levels of ACCESS involvement. DCF remains the designated state agency to determine eligibility for program services/benefits. The Community ACCESS Network works as follows:

DCF's Role	ACCESS Site's Role
 Designate liaison to serve as single point of contact. Provide training to community partner staff as needed. Provide programmatic assistance to community partner staff in their role as an access point. Supply paper applications and literature about programs. Process applications completed at the community partner site, determine eligibility for benefits, and notify applicants of eligibility or ineligibility. 	 Designate liaison to serve as single point of contact. Perform agreed to services. Provide data and pertinent feedback regarding agreed to services. Safeguard client confidential information.

The vision of the DCF ACCESS Florida program is to strengthen Florida's families through private, community, and inter-agency partnerships that promote economic self-sufficiency. Below are levels of services that participants may provide:

Information Site: Provides information and program related materials including paper application

as requested by customers.

Self-Service Site: Information Site plus:

Provides various equipment to customers so they may apply for assistance, check the status of an application or redetermination for benefits, report a

change, or open an account on-line.

Verifies the identify of an applicant.

Provides general assistance in explaining the application process.

Assisted-Service Site: Self Service Site plus:

Provides equipment necessary for customers to apply for benefits, check the status of an application or report a change.

Provides assistance to the customer to submit a web application.

Provides case status information and outstanding information needed to determine eligibility.

Local community partner agencies help DCF provide access to public assistance services. Attached for reference is a listing of the local community partner agencies in the Gainesville/Alachua County area as currently shown on DCF's ACCESS Florida website. As part of the Florida ACCESS program, these agencies provide varying levels of service in the Gainesville/Alachua County area such as information sites, self-service sites and assisted-service sites as defined herein to help increase access to food stamps..

The ACCESS Florida Information Line allows interested persons to obtain information from an automated response service- 24 hours a day, 7 days a week at 1-866-76ACCESS or 1-866-762-2237.

"The Wilhelmina Johnson Center is the only City site listed on the DCF's Access Florida website. I have confirmed with the City of Gainesville Parks, Recreation and Cultural Affairs Department that this City site

only provides the applications for Food Stamps. The site does not process or provide Food Stamps directly to the public."

If the City Commission wishes to expand the DCF Access Florida Program, additional dollars are needed to establish the hours of operation, location and training for the appropriate staff to administer the program.
