**The General Policy Committee will hear an update on Wild Spaces Public Places (WSPP).**

*Commissioner Arreola arrived at 1:05 pm.*

*Dan Hoffman gave a brief introduction.*

*Betsy Waite and Sarit Sela made presentations.*

*Michelle Park and Fred Murry spoke to the matter.*

*Listed below are comments/suggestions from the City Commission:*

*Mayor Poe: 1) Clarence R. Kelly Center - Pull all of the active uses up to NE 17th Street; NE 8th Avenue is good; and put parking on the backside to engage with the neighborhood and sidewalks; 2) Sweetwater Park - could use two to three shade*

structures out in the park (little benches with roofs over them); 3) Revisit the idea of mini skateboard features; and 4) Creating a living music instrument park.

Commissioner Hayes-Santos: 1) Reserve Park - NE 11th street (sidewalks); 2) Bridge over Sweetwater (create an interesting bridge); 3) Connecting Sweetwater on the south (into the alligator head) to the Hawthorne Trail; 4) Work on the Trails Master Plan with the County so the community can see a long-term vision in the community; 5) Forest Park (lights for soccer) (this park is not on the WSPP list, and would have to be funded through the regular CIP); 6) Trash cans and recycling; 7) Adding more parks to areas that were recently annexed (Tower Road and Williston Road); and 8) Rubberized track.

Mayor-Commissioner Pro Tem Budd: 1) A Quinn Jones Museum Improvements - Clean up the parking lot across the street to allow for more parking (as well as bus ingress/egress).

Commissioner Ward: 1) Signage - Tends to not be standard (Needs to tell a story); 2) Hogtown Headwaters Park (Tom Petty opportunity); and 3) Weiss property to be used for an active park (this park is not on the WSPP list).

Staff will report back on the Tom Petty survey at the April 26, 2018 meeting.

Commissioner Warren: 1) Is there a residential structure being incorporated into the plans. Phil Mann stated that the ultimate goal between GRU/Public Works includes the educational building and welcoming center; 2) Activity stations along the trails; and 3) Exercise equipment outdoors.

Commissioner Arreola: 1) Art in public spaces (public art); and 2) Cricket facility.

Jon Reiskind, Robert Hutchinson, Julia Reiskind, Amy Carpus and Meg Neiderhofer spoke to the matter.
