An ordinance of the City of Gainesville, Florida, amending the Zoning Map Atlas and rezoning certain property, as more specifically described in this Ordinance, from the zoning category of "RMF-6: 8-15 units/acre multiple-family residential district" to "CON: Conservation district"; located in the vicinity of South of S.W. 20th Avenue between I-75 and Forest Park; providing a severability clause; providing a repealing clause; and providing an immediate effective date.

WHEREAS, publication of notice of a public hearing was given that the Zoning Map Atlas be amended by rezoning certain property from the zoning category of "RMF-6: 8-15 units/acre multiple-family residential district" to "CON: Conservation district"; and

WHEREAS, notice was given and publication made as required by law and a public
hearing was held by the City Plan Board on May 27, 2010; and

WHEREAS, the City Commission finds that the rezoning of the property described herein will be consistent with the City of Gainesville 2000-2010 Comprehensive Plan; and

WHEREAS, pursuant to law, an advertisement no less than two columns wide by 10 inches long was placed in a newspaper of general circulation and of the public hearing to be held in the City Commission Meeting Room, First Floor, City Hall, in the City of Gainesville at least seven (7) days after the day the first advertisement was published; and

WHEREAS, a second advertisement no less than two columns wide by 10 inches long was placed in the aforesaid newspaper notifying the public of the second public hearing to be held at the adoption stage at least five (5) days after the day the second advertisement was published; and

6	Section 1. The Zoning Map Atlas of the City of Gainesville is amended by rezoning the
7	following described property from the zoning category of "RMF-6: 8-15 units/acre multiple-
8	family residential district" to "CON: Conservation district":
9 10	See Legal Description attached hereto as Exhibit "A", and made a part hereof as if set forth in full.
11	Section 2. The City Manager is authorized and directed to make the necessary changes in
12	the Zoning Map to comply with this Ordinance.
13	Section 3. If any word, phrase, clause, paragraph, section or provision of this ordinance
14	or the application hereof to any person or circumstance is held invalid or unconstitutional, such
15	finding shall not affect the other provisions or applications of the ordinance which can be given
16	effect without the invalid or unconstitutional provisions or application, and to this end the
17	provisions of this ordinance are declared severable.
18	Section 4. All ordinances, or parts of ordinances, in conflict herewith are to the extent of
19	such conflict hereby repealed.
20	Section 5. This ordinance shall become effective immediately upon final adoption; however,
