77	to accomplish such intentions.			
78	Section 3. If any section, sentence, clause or phrase of this ordinance is held to be			
79	invalid or unconstitutional by any court of competent jurisdiction, then said holding shall in no			
80	way affect the validity of the remaining portions of this ordinance.			
81	Section 4. All ordinances, or parts of ordinances, in conflict herewith are to the extent of			
82	such conflict hereby repealed.			
83	Section 5. This ordinance shall take effect immediately upon adoption.
