7	A RESOLUTION OF THE CITY OF GAINESVILLE, FLORIDA,
8 9	AUTHORIZING THE PARTICIPATION OF ELIGIBLE EMPLOYEES IN A RETIREE HEALTH SAVINGS PLAN ADMINISTERED BY
10	THE ICMA RETIREMENT CORPORATION AND PROVIDING AN
11 12	EFFECTIVE DATE.

14	WHEREAS, the City of Gainesville ("Employer") has employees rendering
15	valuable services; and
16	WHEREAS, the establishment of a retiree health savings plan for such
17	employees serves the interests of the Employer by enabling it to provide reasonable
18	security regarding such employees' health needs during retirement, by providing
19	increased flexibility in its personnel management system, and by assisting in the
20	attraction and retention of competent personnel.
21	WHEREAS, the Employer has determined that the establishment of the retiree
22	health savings plan (the "Plan") serves the above objectives:
23	NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of
24	Gainesville, Florida:
25	Section 1. The City of Gainesville hereby adopts the Plan in the form of the
26	ICMA Retirement Corporation's VantageCare Retirement Health Savings Program,
27	including but not limited to the Declaration of Trust of the City of Gainesville, Florida, the
28	Employer VantageCare Retirement Health Savings (RHS) Plan Adoption Agreement
9	and the City of Gainesville Retiree Medical and Dental Expense Reimbursement Plan,

which are attached hereto as Exhibit "A", and by reference made a part hereof as if set
forth in full below.
Section 2. The assets of the Plan shall be held in trust, with the Employer
serving as trustee, for the exclusive benefit of Plan participants and their beneficiaries,
and the assets of the Plan shall not be diverted to any other purpose prior to the
satisfaction of all liabilities of the Plan.
Section 3. The City Manager or designee(s) shall be the coordinator and
contact for the Plan and shall receive necessary reports, notices, etc. and is authorized
to execute any instrument necessary to effectuate the Program.
Section 4. The Mayor-Commissioner and Clerk of the Commission are hereby
authorized to execute the Adoption Agreement and Declaration of Trust on behalf of the
City of Gainesville.
Section 5. This resolution shall become effective immediately upon adoption.
