<sup>1</sup>Florida PRIME's earnings will get a significant boost from ongoing litigation dating back several years. At month-end September, pool participants will benefit from an additional \$5,989,518.33 allocated to interest earnings. This will increase monthly earnings by approximately 30%. Background on the litigation: beginning in 2005, Barclays, Deutsche Bank and others participated in an illegal scheme to manipulate the London Interbank Offered Rate (a.k.a., "LIBOR"). This activity resulted in losses to many investors and financial institutions including the SBA and the local government investment pool. When this was brought to light, civil suits commenced. Attorney General Bondi's office is representing the SBA, and we have recently received our second settlement amount.
