22	hearing was held by the City Plan Board on May 15, 2008; and
23	WHEREAS, the City Commission finds that the rezoning of the property described
24	herein will be consistent with the City of Gainesville 2000-2010 Comprehensive Plan; and
25	WHEREAS, pursuant to law, an advertisement no less than two columns wide by 10
26	inches long was placed in a newspaper of general circulation and of the public hearing to be held in
27	the City Commission Meeting Room, First Floor, City Hall, in the City of Gainesville at least seven
28	(7) days after the day the first advertisement was published; and
29	WHEREAS, a second advertisement no less than two columns wide by 10 inches long was
30	placed in the aforesaid newspaper notifying the public of the second public hearing to be held at the
31	adoption stage at least five (5) days after the day the second advertisement was published; and

WHEREAS, Public Hearings were held pursuant to the published and mailed notices described above at which hearings the parties in interest and all others had an opportunity to be and were, in fact, heard.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FLORIDA:

Section 1. The Zoning Map Atlas of the City of Gainesville is amended by rezoning the following described property from the zoning category of "I-2: General industrial district" to "PS: Public services and operations district":

9 See Legal Description attached hereto as Exhibit "A", and made a part 10 hereof as if set forth in full.

Section 2. The preliminary development plan consisting of: (1) the public services zoning report consisting of 15 sheets and (2) the preliminary development plan maps consisting of 2 sheets, are attached to this Ordinance as Exhibit "B" and made a part hereof as if set forth in full, is approved in accordance with Sec. 30-75 of the Land Development Code.

Section 3. The uses permitted by right on the property described in Section 1 of this Ordinance are Major Group (MG) 91 "Executive, Legislative, and General Government, Except Finance" and IN 4111 "Local and Suburban Transit," that includes the following more specific uses: organizational administration, employee training, employee parking, employee lounge, dispatch operations, fleet maintenance, fleet parking, fueling operations, and customer service; and any accessory uses customarily and clearly incidental to any permitted principal use.

Section 4. The City Manager is authorized and directed to make the necessary changes in the Zoning Map to comply with this Ordinance.
