Written detailed justification is required for these selections (please be specific): RTS submitted a second grant application to the Federal Transit Administration's Low or No Emission Vehicle Grant Program after obtaining City Commission approval on June 7, 2018 to do so. In submitting for various grants, applicants are permitted to form public private partnerships. RTS chose to partner with Center for Transportation and The Environment, Inc. (CTE) because they have been successful with helping other applicants win grants. As the fleet are all Gillig buses, RTS chose to partner with Gillig as the manufacturer of the electric bus. Both CTE and Gillig were named in the grant application, as required by FTA. The Federal Register announcement, April 25, 2018, page 18121, second paragraph under C.1. states that "If an application that involves such a partnership is selected for funding, the competitive selection process will be deemed to satisfy the requirement for a competitive procurement under 49 U.S.C. 5324(a) for the named entities." There are no proposed changes to the partnership. Therefore, the use of Gillig LLC is once again being processed as a specified source.

The Requester hereby certifies that this proposed waiver of non-competitive procurement is based upon an objective review of the required product/service and appears to be in the best interest of the City.
