### **CURRENT ACTION ITEMS**

#### 110665 GRU Cost of Service Study

Explanation: GRU included funding in the FY15 budget to complete a cost of service study to support future rate design. GRU has issued an RFP for consultants to perform a cost of service study that will ultimately be used to support rate proposals for FY16. Specifically, a cost of service study will be performed for each of the electric, gas, water and wastewater systems based on proposed budget for FY 2016. The study will allocate the costs among customer classes for each system and identify the proportion of costs associated with usage charges as they apply to the unbundling of prices as defined in the GRU billing system. The study will include a rate review and design component to develop retail rates and some service charges for all systems; provide options for demand billing for all customer classes, time of use rates, and net metering customer charges in the electric system; recommend rate structures for the water system including multi-family billing; and provide options for methodologies to establish wastewater billing volumes.
