Staff required that the work should be completed and the report given by mid-March, and then staff will bring it to the RUC in April, and receive direction in May.

RECOMMENDATION

The Committee and staff discuss the range of options available for recovering PPA costs, and identify additional information or analysis that might be helpful for future discussion.

Utilities Attorney Shayla McNeill began with an explanation of how some other utilities allocate costs, and Diane Wilson provided a presentation. The committee asked what the consumption of disconnected customers has been. Commissioner Wells asked staff to show the GREC PPA costs per kWh, and also asked that the PPA costs be reorganized in the presentation. The Committee requested that staff show the impact of removing the GREC PPA from the fuel adjustment charge and placing components into base rates "as if GRU owned the plant." Staff will conduct additional research and provide that information in a future meeting.
