3 **An ordinance of the City of Gainesville, Florida, amending Appendix A, Schedule**
4 **of Fees, Rates and Charges of the Code of Ordinances by revising fees, rates and**
5 **charges for adult performance establishment, escort services, and escort licenses;**
6 **alcoholic beverage bottle club license; cable franchise; cemetery, including a ten**
7 **percent surcharge on fees; controlled vehicular parking area decals/permits;**
8 **fire/rescue fire alarm operators, false alarm, prohibited devices, fire alarm**
9 **monitoring companies, fire alarm system contractors, fire inspection, burning**
10 **leaves, brush, clean wood or other vegetative debris, annual burning permit,**
11 **pyrotechnic display; basic air monitoring fee for hazardous material response;**
12 **home occupation permit; land development code fees; parks, recreation and**
13 **cultural affairs facilities and events, including a ten percent surcharge on fees;**
14 **peddlers, solicitors and canvassers; burglar alarm operators, burglar alarm**
15 **monitoring companies, burglar alarm systems contractors, and burglar alarm**
16 **systems; roam towing trespass towing application process fee, registration for**
17 **owners, operators and vehicles, immobilization; registered domestic**
18 **partnerships; secondhand goods dealers; permits for congregating on streets and**
19 **sidewalks; permit to remove, construct, alter curb, driveway, gutter, etc.; traffic**
20 **and motor vehicle parking violations and delinquency and immobilization; solid**
21 **waste and recyclables; stormwater management; and vehicles for hire; Amending**
22 **Section 11.5-31 of Chapter 11.5, Article III, Hazardous Material Cost Recovery**
23 **to include within the definition of costs for recovery, a fee associated with the use**
24 **of a basic air monitoring device; Amending Section 18-17 of Chapter 18, Article**
25 **II, Park Regulation to limit city manager’s authority to set parks and recreation**
26 **fees; Amending Chapter 18, Article II, Park Regulation, by adding a new section**
27 **regarding setting fees for parks, recreation and cultural affairs facilities and**
28 **events; providing directions to the codifier; providing a severability clause;**
29 **providing a repealing clause; and providing an immediate effective date in**
30 **accordance with the schedule provided herein.**

33 **WHEREAS,** at least ten (10) days’ notice has been given once by publication in a
34 newspaper of general circulation notifying the public of this proposed ordinance and of the
35 public hearings in the City Hall Auditorium located on the first floor of City Hall in the City of
36 Gainesville; and

37 **WHEREAS,** public hearings were held pursuant to the published notice described above,
38 at which all interested parties had an opportunity to be, and were, in fact, heard.

39 **NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE**
40 **CITY OF GAINESVILLE, FLORIDA:**

1 **Section 1.** Portions of Appendix A of the Code of Ordinances, relating to fees, rates or
 2 charges are amended as set forth in Exhibit “A,” attached to this ordinance and incorporated by
 3 reference as if fully set forth herein. Except as amended herein, the remainder of Appendix A
 4 remains in full force and effect.

5 **Section 2.** The definition of “cost” within Section 11.5-31 in Chapter 11.5 Health and
 6 Sanitation, Article III. Hazardous Materials Incident Recovery Cost, of the Code of Ordinances
 7 is amended to read as follows. Except as amended herein, the remainder of Section 11.5-31
 8 remains in full force and effect.

9 **Sec. 11.5-31. - Definitions.**

10 *Cost(s)* shall mean and include, but is not limited to:

- 11 (1) All costs incurred for response, containment and/or removal and disposal of
 12 hazardous materials or initial remedial action.
- 13
- 14 (2) Costs of any health assessment or health effects study and related treatment
 15 carried out for responding personnel as a necessity resulting from a hazardous
 16 material incident.
- 17
- 18 (3) Labor, including benefits, overtime and administrative overhead, exclusive of
 19 normal departmental operations.
- 20
- 21 (4) The cost of operating, leasing, maintaining, repairing, and replacement where
 22 necessary of any equipment.
- 23
- 24 (5) Contract labor and equipment.
- 25
- 26 (6) Materials, including but not limited to, absorbents, foam, dispersants, overpack
 27 drums, or containers.
- 28
- 29 (7) Supervision of clean up and abatement.
- 30
- 31 (8) Labor and equipment obtained directly by the city, their agencies or agents, and
 32 other agencies.
- 33
- 34 (9) A fee as set forth in Appendix A for the use of a Basic Air Monitoring Device
 35 when an abnormal value is identified in the atmosphere or substance. The fee

1 represents a portion of the cost associated with replacement of the sensors within
2 the Basic Air Monitoring Device.

3
4 **Section 3.** Section 18-17 in Chapter 18, Parks and Recreation, Article II. Park

5 Regulations, of the Code of Ordinances is amended to read as follows.

6 **Sec. 18-17. Authority of city manager to promulgate rules and regulations.**

7 The city manager is authorized to promulgate rules and regulations for the purpose of regulating
8 the use of public buildings, parks and playgrounds, limiting the hours during which the same
9 shall be open to the public, ~~establishing admission fees as may be requisite therefor, and~~
10 providing standards of conduct for persons while using such buildings, parks and playgrounds.

11 The city manager may establish fees for parks, recreation and cultural affairs facilities, and
12 events if those fees are not otherwise established in Appendix A – Schedule of Fees, Rates and
13 Charges.

14 **Section 4.** Chapter 18, Parks and Recreation, Article II. Park Regulations, of the Code of
15 Ordinances is amended to include a new section regarding admission and participation fees.

16 **Sec.18-23. Park and Recreation Fees.**

17 Fees for admission to city parks, and for use of recreation and cultural affairs facilities,
18 and for participation in recreational events are set forth in Appendix A – Schedule of Fees, Rates
19 and Charges. Certain fees in Appendix A include a ten percent surcharge. The ten percent
20 surcharge on fees, except where identified in Appendix A as exempted, is a mandatory addition
21 to each fee and may not be waived.

22 **Section 5.** It is the intention of the City Commission that the provisions of Sections 1
23 through 4 shall become and be made a part of the Code of Ordinances of the City of Gainesville,
24 Florida, and that the Sections and Paragraphs of this Ordinance may be renumbered or relettered
25 in order to accomplish such intentions.

1 **Section 6.** If any word, phrase, clause, paragraph, section or provision of this ordinance
 2 or the application hereof to any person or circumstance is held invalid or unconstitutional, such
 3 finding shall not affect the other provisions or applications of the ordinance which can be given
 4 effect without the invalid or unconstitutional provisions or application, and to this end the
 5 provisions of this ordinance are declared severable.

6 **Section 7.** All ordinances, or parts of ordinances, in conflict herewith are to the extent of
 7 such conflict hereby repealed.

8 **Section 8.** This ordinance shall take effect immediately upon adoption; provided
 9 however, the fees, rates and charges set forth herein shall be applicable to fees, rates and
 10 charges which are due and payable after 12:01 A.M. on October 1, 2013, provided however,
 11 new fees, rates and charges are not applicable to reservations of parks, recreational or cultural
 12 facilities, if the reservation was booked prior to the effective date of this ordinance.
