

1 **ORDINANCE NO. 100223**

4 **An ordinance of the City of Gainesville, Florida, amending the**
5 **City of Gainesville Code of Ordinances, relating to fees;**
6 **amending the stormwater management section of Appendix A**
7 **by increasing the fees; providing directions to the codifier;**
8 **providing a severability clause; providing a repealing clause;**
9 **and providing an immediate effective date in accordance with**
10 **the schedule provided herein.**

12 **WHEREAS**, at least 10 days notice has been given once by publication in a
13 newspaper of general circulation notifying the public of this proposed ordinance and of a
14 public hearing to be held in the City Commission Auditorium, City Hall, City of
15 Gainesville; and

16 **WHEREAS**, the Public Hearings were held pursuant to the published notice
17 described at which hearings the parties in interest and all others had an opportunity to be
18 and were, in fact, heard.

19 **NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION**
20 **OF THE CITY OF GAINESVILLE, FLORIDA:**

21 **Section 1.** Appendix A, relating to Stormwater Management fees,
22 is amended to read as follows:

- 23 a.—Monthly fee for each equivalent residential unit (ERU)
24 period commencing October 1, ~~2010-2007~~ through
25 September 30, 2008 8.15 ~~7.90~~
- 26 b.—Monthly fee for each equivalent residential unit (ERU)
27 unit (ERU), period commencing October 1, 2008 through
28 September 30, 2009 ~~7.65~~
- 29 c.—Monthly fee for each equivalent residential unit (ERU),
30 period commencing October 1, 2009 ~~7.90~~
- 31

32 **Section 2.** It is the intention of the City Commission that the provisions of
33 Section 1 shall become and be made a part of the Code of Ordinances of the City of

1 Gainesville, Florida, and that the Sections and Paragraphs of this Ordinance may be
2 renumbered or relettered in order to accomplish such intentions.


3 **Section 3.** If any section, sentence, clause or phrase of this ordinance is held to
4 be invalid or unconstitutional by any court of competent jurisdiction, then said holding
5 shall in no way affect the validity of the remaining portions of this ordinance.

6 **Section 4.** All ordinances, or parts of ordinances, in conflict herewith are to the
7 extent of such conflict hereby repealed.

8 **Section 5.** This ordinance shall take effect immediately upon adoption;
9 provided however, the rates and charges as provided for herein shall be applicable to
10 all monthly bills which are for the first time rendered and postmarked after 12:01
11 A.M., October 1, 2010.


