RELEASE OF EASEMENT

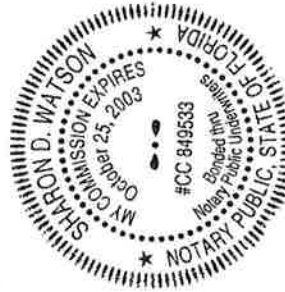
