AMENDMENT TO THE AGREEMENT BETWEEN THE CITY OF GAINESVILLE AND KEEP ALACHUA COUNTY BEAUTIFUL, INC., FOR THE GREAT AMERICAN CLEANUP, BEAUTIFUL BLOCK PROGRAM, AND GRAFFITI REMOVAL

THIS FIRST AMENDMENT TO THE AGREEMENT is entered into this	_day of
2002 between the City of Gainesville, a municipal corporation	on in
Alachua County, Florida, hereinafter referred to as the "CITY," and Keep Alachu	a
County Beautiful, a Florida nonprofit corporation, hereinafter referred to as the	
"PROVIDER."	

WHEREAS, the CITY and the PROVIDER have previously entered into an agreement for the Great American Cleanup and the Beautiful Block Program dated September 24, 2001; and

WHEREAS, the CITY and the PROVIDER wish to add Graffiti Removal to the Scope and Schedule of Services;

NOW, THEREFORE, the parties hereto agree as follows:

1. Section 4 SCOPE AND SCHEDULE OF SERVICES is amended to include in Attachment 1, the following additions:

Attachment 1

V.

- A. Obtaining a "Right of Entry" permit from each owner/tenant of private property where graffiti will be removed. A copy of this form is included as Attachment 3.
- B. Remove graffiti from public and private property. The goal is to remove or cover graffiti within three (3) business days of the time it is referred to or discovered by the PROVIDER.
- C. Establish and maintain accurate records of: TYPE OF GRAFFITI REMOVED; LOCATION OF GRAFFITI REMOVAL; TYPE OF OBJECT(S) DEFACED; SIZE OF THE AREA OF THE OBJECT DEFACED; FREQUENCY OF GRAFFITI / VANDALISM AT A GIVEN LOCATION; TIME REQUIRED FOR SUFFICIENT REMOVAL; AMOUNT AND COST OF MATERIALS USED FOR REMOVAL; RESPONSE TIME BETWEEN GRAFFITI REFERRAL AND ITS REMOVAL; REFERRAL NAME AND CONTACT NUMBER; AND A DISTINCTION BETWEEN PRIVATE AND PUBLIC PROPERTY.

- D. The period of this pilot program is six months in duration, from April 1, 2002 through September 30, 2002.
- E. The PROVIDER is responsible for removing all waste associated with graffiti removal.
- F. Subcontractors shall be allowed only with the prior written approval of the CITY.
- 2. Section 5 FUNDING AND PAYMENT PROCEDURES is amended to include in 5.1, the following additions:

Section 5

5.1

In addition to the \$15,000 in-kind services funds, the \$15,000 contribution to renew its membership in Keep Alachua County Beautiful, and the \$10,000 for the continued implementation of "The Beautiful Block Program," the City will provide for additional funding up to, but not to exceed \$10,000 for graffiti removal and public education programs for graffiti prevention.

3. This amendment, when executed, together with the original agreement, constitutes the entire agreement between the parties.

SAVE and EXCEPT as expressly amended herein, all other terms and provisions of the original agreement between the parties, dated September 24, 2001, shall be and remain in full force and effect.
