### 080638. "Wild Spaces and Public Places" - Environmental Lands, Parks, Recreation One-Half Percent Sales Tax (B)

This item involves discussion of the One-Half Percent Sales Tax to acquire and improve conservation lands and create, improve and maintain parks and recreational facilities.

Wild Spaces and Public Spaces Committee Members Robert Hutchinson and Jack Hughes; City Manager Russ Blackburn; and Alachua County Attorney Dave Wagner gave presentations.

MOTION: Commissioner Donovan moved and Commissioner Poe seconded to direct staff to: 1) Work with Alachua County to establish a citizen oversight committee of five members structured as suggested by the "Wild Spaces & Public Places" Committee (not inclusive of public officials or public staff); 2) direct City staff to maintain public information that would be available at least quarterly that indicate the status of planned and completed projects and the amount of local funds and matching funds expended; 3) conduct and present to the public an annual independent audit; 4) provide for a sign or a plaque to be placed on or near any substantial facilities being built, and on land purchased that says: "Funding in part by Wild Spaces & Public Places a local sales tax approved by the voters in 2008"; 5) direct City staff in coordination with the County staff move forward with the implementation plans to be presented hopefully sometime in January, 2009. (VOTE: 6-0, Commissioner Mastrodicasa - Absent, MOTION CARRIED)
