A change order to the original contract with Nichols Construction is requested and herein submitted.

Scope Change

The documents sent out for bidding were actually the preliminary documents and not the approved final documents. The preliminary documents identified the project limit at NW 9 Place and the project length of 1243'. The approved final plans correctly identified the project limit of NW 8 Avenue and the project length of 1748'.

The contractor based his bid on the 1243' representation in the bid documents he received.

Compensation Change

The original total bid is \$38,850, of which \$36,550 was for the Stream Debris Removal item. The requested compensation for the Stream Debris Removal item is \$51, 397. This is an increase in this item of \$14,847.
