Dear Mayor Hanrahan:

I received your letter requesting that the University of Florida amend its code of student conduct to allow the University to hold students accountable for violations of city ordinances

The maintenance of a positive and productive relationship with our community is a priority for the University of Florida We have been pleased to learn that the new landlord point system has had a positive impact on code violations in student housing areas. In addition, the UF participants in the Best Practices Conference reported that their time was very well spent and that the conference provided opportunities for new town/gown connections

The presence of Nora Kilroy on our staff as the Assistant Dean of Students and Director of Off-Campus Life has been well received by the Gainesville Police Department and by student-occupied neighborhoods. In fact, this year she was honored with the Police Service Award at the Gainesville Police Awards Ceremony.

We are optimistic that the efforts by the Office for Off-Campus Life will continue to enhance students' respect for and behavior in the community. We realize, however that there are a very small number of students for whom a positive approach will not be sufficient. While these students may not be sanctioned through formal judicial procedures, we are informed by GPD and address the repeat offenders. Ms. Kilroy will send them a letter and often requires that they meet with her to discuss their conduct or behavior. This approach appears to be having a positive effect in reducing further unwelcome behavior.

Our current student government officers are making community involvement a priority for their administration. They will also be seeking more involvement with city and county governmental leadership. The result of this focus will be student-to-student communication regarding positive interface with the Gainesville community.

While the University addresses student misconduct off-campus and fully supports the efforts of city, county, state, and federal officials to enforce ordinances and laws, University policy does not allow us to enforce city codes through the student judicial process. The University can neither duplicate the efforts nor enforce the regulations of another entity. The University will take action when required to do so by law or when the violation interferes with the educational process or the orderly operation of the University. In addition, action will be taken when the health, safety, or welfare of the campus is at issue, when intimidation of another student occurs, or when the violation is of such a serious nature that the suitability of a student as a member of the campus community is at issue. As you know, through the efforts of the Community Alcohol Coalition, we have agreed to handle any off-campus DUI convictions through the judicial system.

We look forward to continuing our work with you, with the City of Gainesville, and with Alachua County to assure that the interface between UF students and the community is beneficial for all concerned.

Dear Mayor Hanrahan,

Thank you for your letter of February 15, 2007, in which you asked that Santa Fe Community College amend its Student Conduct Code to hold students accountable for serious and repeated violations of city ordinances For your convenience, I attach a copy of our current Student Conduct Code, which I am pleased to report already contains the following section:

C Violation of Law and College Discipline

- Notwithstanding anything stated in Section B. above, College disciplinary proceedings may be instituted against a student charged with violation of a law, regardless of where the violation occurred or whether it was a violation of this Code, for example. Proceedings under this Code may be carried out prior to, simultaneously with, or following civil or criminal proceedings
- When a student is charged by federal, state, or local authorities with a violation of law, the College will not request or agree to special consideration for that individual because of his or her status as a student. If the alleged offense is also the subject of a proceeding before a judicial body under the Code, however, the College may advise off-campus authorities of the existence of the Code and of how such matters will be handled internally at the College. The College will cooperate fully with law enforcement and other agencies in the enforcement of criminal law on campus and in the conditions imposed by criminal courts for the rehabilitation of student violators. Individual students and faculty members, acting in their personal capacities, remain free to interact with governmental representatives as they deem appropriate.

In addition, as a reminder, the College has an agreement with the City Attorney for expeditious handling via the student judicial process of violations of Municipal Ordinances that occur on property owned or leased by Santa Fe Community College. I enclose a copy for your review
