THIS CAUSE, having come for Public Hearing before the Code Enforcement Board on January 13, 2011, after due notice to Respondent, BONNIE LASLO, the Board issues its Order Imposing Fine and Costs as follows:

It is ORDERED that:

- Respondent, BONNIE LASLO, is found guilty of violating Section 13-2(b)(1), 13-76(g), 13-96(d), 13-127(1), 13-127(10), 13-141(b) of the Gainesville Code of Ordinances existing at 3443 NW 1st Court, Gainesville, Florida, also known as Tax Parcel 06494-005-000.
- Respondent shall have 10 days from the date of the issuance of this Order to correct said violation and to come into compliance with the Code of Ordinances.
- Should Respondent fail to comply with the Order by said date, then in that event, Respondent shall pay a fine of \$100.00 per day for each and every day said violation continues to exist at the above address past the time set by the Board.
- Costs for prosecuting this case shall be assessed in the amount of \$152.95 payable by the Respondent to the Petitioner.

If not complied with, this Order shall constitute a lien against Tax Parcel 06494-005-000, also known as 3443 NW 1st Court, Gainesville, Florida and any and all real or personal property owned by BONNIE LASLO, pursuant to Sec. 162.09, F.S., and may be recorded in Public Records of Alachua County.
