*Mission Statement*

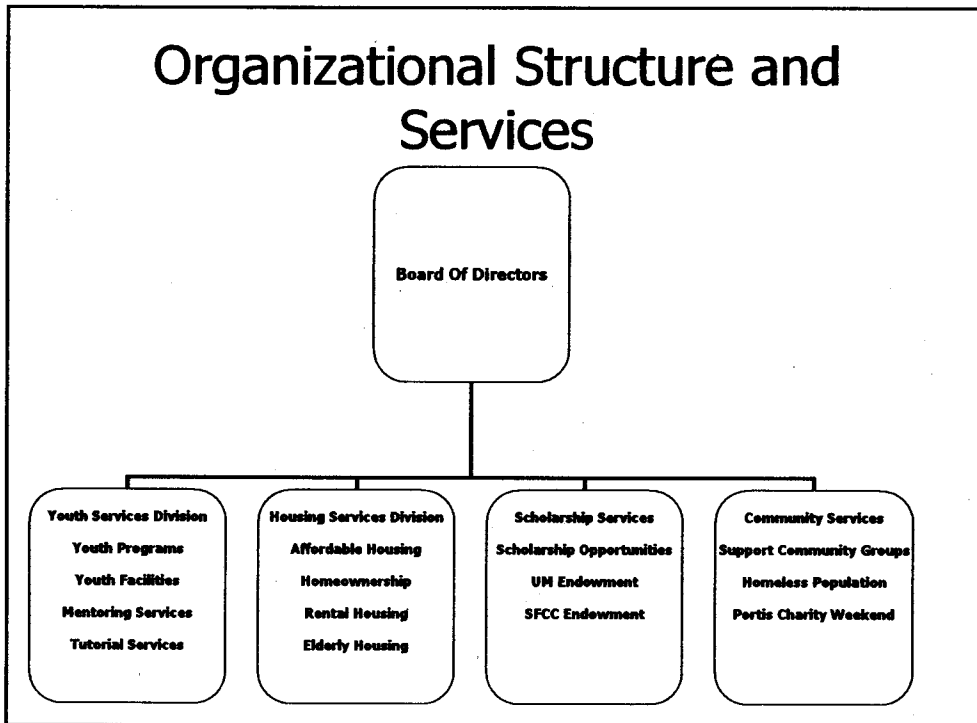

Dear Applicant:


