RE: Petition 30WSU-01 CC. Watson Construction, agent for Conrad Yelvington Distributors, Inc. A special use permit for Wellfield Protection and development plan review for construction of a concrete batch plant and asphalt plant with associated aggregate storage and master stormwater design. Zoned: I-2 (general industrial district). Located in the 7600 block, east of US 441.

This notice has been mailed to you because the proposal for this petition is located on property you own according to the latest tax roll available to the City.

The City Plan Board heard this petition on April 19, 2001 and voted to recommend to the City Commission that the petition be denied. The City Plan Board acts in an advisory capacity to the City Commission.

A PUBLIC HEARING will be held by the CITY COMMISSION on Monday, May 14, 2001, at 6:00 P.M., or as soon thereafter as may be heard, in the City Hall Auditorium, First Floor, 200 East University Avenue, Gainesville, Florida. Following the public hearing, based on the testimony provided, the City Commission will then either vote to approve, deny or continue the petition.

### CITY COMMISSION HEARING

This matter will be conducted as an informal quasi-judicial hearing by the City Commission, unless the petitioner(s) or affected parties file for a formal quasi-judicial hearing. All persons that are entitled to actual written notice of this petition, pursuant to Chapter 30, Gainesville Code of Ordinances, may submit a completed Quasi-Judicial Registration Form to request a formal quasi-judicial hearing prior to the public hearing that will be held by the City Commission. The request must be made no less than 7 days prior to the meeting date of the public hearing as shown above. All requests for a formal quasi-judicial hearing, along with review materials (written evidence and/or other form of documentation) must be submitted to: Clerk of the City Commission, located at City Hall, First Floor, 200 East University Avenue, Gainesville, Florida. Mailed requests and review materials must be received by the Clerk of the Commission at least 7 days prior to the public hearing. Failure to timely file a written request for a formal hearing shall set the petition for an informal quasi-judicial hearing.
