ORDINANCE NO. _ 1 2 3 An ordinance of the City of Gainesville, Florida, amending 4 Appendix I of the City Charter, by redefining the Legal 5 Description of Municipal Corporate Limits, as more 6 specifically described in this Ordinance; providing directions 7 to the codifier; providing directions to the Clerk of the 8 Commission; providing a severability clause; providing a 9 repealing clause; and providing an immediate effective date. 10 11 12 WHEREAS, at least 10 days notice has been given once by publication in a newspaper 13 14 of general circulation notifying the public of this proposed ordinance and of a public hearing to be held in the City Commission Auditorium, City Hall, City of Gainesville; and 15 16 WHEREAS, the Public Hearings were held pursuant to the published notice described at 17 which hearings the parties in interest and all others had an opportunity to be and were, in fact, heard. 18 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE 19 CITY OF GAINESVILLE, FLORIDA: 20 **Section 1.** Appendix I of the City Charter is hereby replaced in its entirety with the 21 revised Appendix I, attached hereto as Exhibit "A", and made a part hereof as if set forth in full. 22 **Section 2.** It is the intention of the City Commission that the provisions of Section 1 of 23 this ordinance shall become and be made a part of the Charter Laws of the City of Gainesville, 24 Florida. 25 **Section 3.** The corporate limits of the City of Gainesville, Florida, as set forth in the 26 27 Appendix I, Charter Laws of the City of Gainesville, are amended and revised as described in
