Summary:

Officers began the detail at 1245hrs and dealt with large crowds throughout the assignment till 2400hrs. Officers responded to numerous calls for service to include medical emergencies and disturbances. 2 Shift 4 officers were called in early to assist with crowd control from 1800hrs to 2200hrs.

Game Related Incidents Handled by Neighborhood Detail & Patrol:

11-24599 – Agg. Battery / Agg. Assault / Battery – 1300 WUA – 1727 hours: The UF fan victim argued with FSU fan, Robert J. Keller WM 02/18/84. Keller intentionally shoved the victim into moving traffic and then punched him in the face. Keller's friend, Wesley K. Ponder BM 12/11/77, came out into the roadway and punched the victim in the face, knocking him to the ground. Ponder then boot stomped the victim's head against the curb. The victim was rendered unconscious. There were several neutral witnesses in traffic. Ponder ran from the scene. Ofc. F. Perez persuaded Ponder's girlfriend to call him and bring him back. He returned. Ofc. Steve Jones arrested both Keller and Ponder. The victim was transported to Shands and treated for a concussion. He did not remember most of the day. ASODOJ x 2.

11-24635, Robbery (strong arm), 700 NW 17th St: At approximately 0005 hrs Ofc Pandak was contacted by the victim, Drew Ryan Pinero W/M 08-31-89. Pinero stated as he was walking to midtown from a friends residence, he was attacked in the area of 700 NW 17th St. Pinero observed 3 W/M's that looked suspicious. Pinero attempted to cross away from the individuals, moments later he heard footsteps and realized he was being tackled by one of the individuals. The other two joined in holding him down in a choke hold. On of suspects was yelling for Pinero to give up his wallet, while a second suspect was going through his pockets. The suspect removed his wallet and cell phone as another suspect held his hand over Pinero' mouth. They threatened him with a gun but one was never seen. All three suspects continued to kick and punch Pinero, causing the injuries to his head and face. All three suspects then fled east on NW 7th Ave. Pinero then walked to 1700 W University Ave where he was able to contact Ofc Pandak. Pinero was treated for his injuries and advised that stitches were needed for the cuts to his face. Pinero refused to be transported. Ofc Pandak and Det Mullins took Pinero back to the scene to look for evidence. The three suspects descriptions were:

- 1 W/M Black tank top 5'07 stocky tattoos on his bisep, short dark hair, wearing blue jeans.
- 2. W/M 6'0" black tank thin, dark hair blue jeans
- 3. W.M 6'0" gray tank top., thin build, dark hair, blue jeans.

11-24631, Felony Battery, 1910 Stadium Rd (President's Skyboxes): Tygh Landon Bailes W/M 06-12-76 was involved in a physical altercation in the President's Skybox at Florida field. Bailes kicked another participant in the head causing the victim to fall
