

On March 11, 2021, President Joe Biden signed into law the <u>American Rescue Plan</u> <u>Act of 2021</u>, a \$1.9 trillion COVID-19 relief package

### HOME-American Rescue Plan (HOME-ARP)

**City of Gainesville Expenditure Deadline – September 30, 2030** 

Provides \$5 billion to assist individuals or households who are homeless, at risk of homelessness, and other vulnerable populations, by providing housing, rental assistance, supportive services, and non-congregate shelter, to reduce homelessness and increase housing stability across the country. These grant funds will be administered through HUD's

### **HOME Investment Partnerships Program (HOME)**

The 651 State and local Participating Jurisdictions (PJs) that qualified for an annual HOME Program allocation for FY 2021 are eligible to receive HOME-ARP grants.





# **ELIGIBLE ACTIVITIES**

- Homeless
- At-Risk of Homelessness
- Fleeing, or attempting to flee domestic violence, dating violence, sexual assault, stalking or human trafficking

Qualifying Populations

- Other Populations where providing supportive services or assistance would prevent a family's homelessness or would serve those with the greatest risk of housing instability
- Veterans and Families that include a Veteran Family Member (Must meet the criteria above to be eligible)



# **CDBG-CV Program**

The Community **Development Block Grant** CARES Act (CDBG-CV) program provides grants to states, insular areas, and local governments to prevent, prepare for, and respond to the spread of COVID-19

The City of Gainesville has received three (3) tranches of CARES Act (CDBG-CV) funding

- CDBG-CV1: HUD funding \$800,608. The GNVCares About Neighbors Program provided rent, mortgage and utility assistance to LMI Neighbors. Commission approved on April 27, 2020 – File# 191160. <u>COMPLETED</u>
- CDBG-CV2: State of Florida funding \$552,098 provided for Coronavirus Relief Fund (CRF) Program. A utility assistance initiative for LMI Neighbors. Commission approved on September 3, 2020 - File # 200260. Subsequent update from the State of Florida allowed mortgage and rent assistance. Commission approved on December 3, 2020 – File# 200564. COMPLETED
- CDBG-CV3: HUD funding of \$1,001,999. City Commission approved activities include Public Services and Housing Activities. Commission approved on July 29, 2021 – File# 210198. IN PROCESS

# **Activities Timeline**

#### May-July 2022:

Community Engagement activities and Conduct Needs Assessment and Gap Analysis using current local, state and federal data and input from community engagement efforts.

Analyze and summarize community engagement efforts.

#### May-August 2022:

Preparation of the Allocation Plan using the HUD-provided template. The Plan will be submitted in HUD's Integrated Disbursement and Information System (IDIS) as a substantial amendment to the FY21-22 Annual Action Plan.

#### August 2022:

Strategy session between Florida Housing Coalition, City leadership and HCD staff to prioritize housing and community development needs/goals identified through the engagement process and data analysis.

Create a strategic outline informing the use of the City's HOME-ARP and CDBG-CV3 funds.

#### September 2022:

Preparation of public notice and public hearing materials.

#### October 2022:

City Commission presentation seeking approval to submit allocation request to HUD for review.
