Dear-Mr. Hencin;

On September 3, 1999 the City of Gainesville transferred property at 105 SE 13th Lane (Tax Parcel #15955-007-000) to Alachua Habitat using a Special Warranty Deed. Habitat has built a home on that property for the benefit of a very low-income family in our community. In preparation to transfer that home to the Habitat family, our agent identified a clause stipulating that the property would "automatically revert to Grantor [the City of Gainesville] in the following events: 1) the Grantee [Alachua Habitat] does not commence and complete the construction of single family buildings on the heretofore described property within (2) years from date of execution . . .".

We commenced construction within the required time frame for Habitat partner family, Barbara Warrick. However, relatively soon thereafter, due to a job transfer, Ms. Warrick and her family moved out of Florida. Because Habitat only builds homes with the participation of the family that will live in it, until another family could be identified for that particular home work on the site halted. The site was selected again in 2002 and the home was started and completed in 2003 for another very low-income family, Sheila McCray and her son, Ward. The completion, for the reason stated, was not prior to the expiration of the above mentioned clause.

Since the property was conveyed to Alachua Habitat before the tenure of the current Habitat administration, the terms of the Special Warranty Deed were not realized until now.

Alachua Habitat requests that the City of Gainesville extend the terms of the Special Warranty Deed through December 31, 2004, to allow Alachua Habitat transfer the property for the original purpose of providing a single family residence to a low-income family in Gainesville, Florida. Ms. McCray does meet the income requirements as defined in 24 Code of the Federal Regulation Part 92.2 (1996) and will use this home as her primary residence. She has occupied the home since its completion in November, 2003.
