#### **City of Gainesville - Alachua County 10-Year Plan to End Homelessness (B)**

**The 10-Year Plan to End Homelessness in Gainesville and Alachua County was presented to the public at a second community-wide Summit on Homelessness on December 1, 2005. The 10-year plan is now being presented at a joint meeting of the Gainesville City Commission and the Alachua County Board of County Commissioners for their consideration.**
