An ordinance of the City of Gainesville, Florida, amending the Zoning Map Atlas and rezoning certain property, as more specifically described in this Ordinance, from the zoning category of "RMF-7: 8-21 units/acre multiple-family residential district" to "MU-1: 8-30 units/acre mixed use low intensity"; located in the vicinity of 1308 E. University Avenue and 13 Northeast 13^{th} Street; providing a severability clause; providing a repealing clause; and providing an immediate effective date.

WHEREAS, publication of notice of a public hearing was given that the Zoning Map Atlas be amended by rezoning certain property from the zoning category of "RMF-7: 8 - 21 units/acre multiple-family residential district" to "MU-1: 8 – 30 units/acre mixed use low intensity"; and

WHEREAS, notice was given and publication made as required by law and a public hearing was held by the City Plan Board on January 27, 2011; and

WHEREAS, the City Commission finds that the rezoning of the property described herein will be consistent with the City of Gainesville 2000-2010 Comprehensive Plan; and

WHEREAS, This ordinance shall become effective immediately upon final adoption; however, the rezoning shall not become effective until the amendment to the City of Gainesville 2000-2010 Comprehensive Plan adopted by Ordinance No. 100681 becomes effective as provided therein; and

WHEREAS, at least ten (10) days notice has been given of the public hearing once by publication in a newspaper of general circulation notifying the public of this proposed ordinance

13	family residential district" to "MU-1: $8-30$ units/acre mixed use low intensity":
