13	Section 2. The City reserves unto itself, its successors and assigns a public and private		
14	utilities easement over, under, across and through the right-of-way described in Exhibit "A",		
15	attached hereto and made a part hereof, for the purpose of installing, maintaining and operating		
16	public and private utilities.		
17	Section 3. The Clerk of the Commission or designee is authorized to record a true copy		
18	of this Ordinance in the Public Records of Alachua County, Florida.		
19	Section 4. If any section, sentence, clause or phrase of this ordinance is held to be invalid		
20	or unconstitutional by any court of competent jurisdiction, then said holding shall in no way		
21	affect the validity of the remaining portions of this ordinance.		
22	Section 5. All ordinances, or parts of ordinances, in conflict herewith are to the extent of		

such conflict hereby repealed.
