# **1080465.** Initiative 2.4: Ensure Transparent, Efficient and Consistent Regulation of Land Development In Furtherance Of The Comprehensive Plan (B)

Planning & Development Director Erik Bredfeldt and gave a brief history and overview of this item. The Committee heard a presentation from Mr. Michael Lauer of Planning Works with additional input from City staff, such as Planning Manager Ralph Hilliard. Mr. Lauer presented the Committee with a first draft of proposed amendments to the Comprehensive Plan and Land Development Code. Mr. Hilliard gave a brief update on how the consultant and staff have been working to identify areas that can be designated as Activity Centers.

Mr. Lauer invited Commissioners and citizens to ask questions and provide input and comments. Chair Hawkins submitted a memorandum of his comments on the proposed amendments into the record. Input was also received by several individuals at the meeting including:

The Committee reviewed and discussed the staff recommendation and agreed to have planning and legal staff do additional work on this item and bring it back to a Special Meeting at the end of April. A particular area of concern that needed more work and information for discussion was the "tear down" amendment.

#### RECOMMENDATION

The CDC hear a: 1) status report from staff and the consultant on progress of the proposed revisions to the Comprehensive Plan and Land Development Code; 2) review materials provided and suggest any alternative direction; 3) direct staff to meet with stakeholders to further refine the work product; and, 4) move this referral to the City Commission with recommendation to initiate a Petition to the Plan Board.
