A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FLORIDA, REQUESTING AN EASEMENT FROM THE BOARD OF TRUSTEES OF THE INTERNAL IMPROVEMENT TRUST FUND OF THE STATE OF FLORIDA; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Gainesville – Gainesville Regional Utilities, proposes to upgrade and replace sanitary sewer and lift station facilities on property leased to North Florida Evaluation and Treatment Center at Tacachale and the Florida Department of Children and Families, owned by the Board of Trustees of the Internal Improvement Trust Fund of the State of Florida; and

WHEREAS, these utilities are necessary to serve the North Florida Evaluation and Treatment Center at Tacachale located at 1200 NE 55th Boulevard; and

WHEREAS, the acquisition of a certain easement is necessary to accomplish this installation on State property; and

NOW, THEREFORE BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FLORIDA:

Section 1. The City of Gainesville hereby request that the State of Florida

Department of Environmental Protection obtain authority from the Board of Trustees of
the Internal Improvement Trust Fund of the State of Florida to grant an easement over
State property for the purpose of installing, operating and maintaining a sanitary sewer
and lift station facilities and related appurtenances; and

Section 2. That the easement which is necessary for the purposes herein stated, is more specifically described as follows:

Legal Description:

A twenty-five foot wide public utilities easement situated in Section 36, Township 9 South, Range 20 East, being more particularly described as follows:

Commence at the Southwest corner of said Section 36, for a Point of Reference and run N00°59'06"W, a distance of 1324.04 feet; thence run N88°53'54"E, a distance of 950.00 feet; thence run N01°06'06"W, a distance of 970.00 feet to the South line of a fifty-foot wide public utilities easement recorded in Official Records Book 1043, Page 777 of the Public Records of Alachua County, Florida; thence run N 88°53'54"E, along said South line, a distance of 25.00 feet to the Southeast corner of said public utilities easement and to the Point of Beginning; thence continue N88°53'54"E, a distance of 25.00 feet; thence run N01°06'06"W, parallel with the East line of said public utilities easement, a distance of 175.00 feet; thence run S88°53'54"W, a distance of 25.00 feet to said East line; thence run S01°06'06"E, along said East line, a distance of 175.00 feet to the Point of Beginning.

Section 3. This Resolution shall become effective immediately upon adoption.
