A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FLORIDA, APPOINTING MEMBERS OF THE CITY OF GAINESVILLE AFFORDABLE HOUSING ADVISORY COMMITTEE AS REQUIRED BY THE STATE HOUSING INITIATIVES PARTNERSHIP PROGRAM ACT, SECTIONS 420.9072 AND 420.9076, FLORIDA STATUTES; PROVIDING FOR THE TERMS OF APPOINTMENT OF THE MEMBERS; PROVIDING A REPEALING CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the 2007 Florida Legislature, as part of House Bill1375, revised the State Housing Initiatives Partnership Program Act, Subsections 420.907-420.9079, Florida Statutes, (the "Act") to require all counties and municipalities in the State of Florida to establish Affordable Housing Advisory Committees; and

WHEREAS, on April 14, 2008, the City of Gainesville adopted Ordinance No. 070872 establishing the City of Gainesville Affordable Housing Advisory Committee (the "Advisory Committee") as required by the Act; and

WHEREAS, Ordinance No. 070872 was codified in Sections 14-1, 14-6 and 14-7 of the City of Gainesville Code of Ordinances; and

WHEREAS, the Act requires the City Commission to appoint members to the Advisory Committee by Resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FLORIDA:
