NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FLORIDA:

Section 1. The section entitled "LAND DEVELOPMENT CODE" in Appendix A (Schedule of Fees, Rates and Charges) of the Code of Ordinances is amended as follows:
