MOTION (REFERRAL):

The City Commission refer to staff to: 1) Move forward with a meeting with the Gainesville Housing Authority and the Gainesville Florida Housing Corporation Board; 2) see if there is a way of developing a measure of effectiveness of different housing providers; 3) look into developing design assistance for affordable housing regarding construction type and to ensure that the homes are as beautiful as they can be within the price parameters; 4) come back with information on clearing up titles and putting lots back into the pool of eligible properties that could be used for affordable housing; 5) look into some kind of Ad Hoc Affordable Housing Advisory Board to review the state laws and what we're doing in local practice; 6) do preliminary research on Hope VI type projects and also forward to the Gainesville Housing Authority; and 7) review the study that Commissioner Braddy submitted "Housing Supply and Affordability: Do Affordable Housing Mandates Work?"; and bring back recommendations to the City Commission.

RECOMMENDATION

Hear a presentation from Community Development staff on the issues identified; hear presentations from the local nonprofit affordable housing providers, and discuss issues with the Gainesville Housing Authority.
