	Explanation	On June 25, 2014, the City's Purchasing Division received six (6) bids from responsible responsive bidders for Restroom Renovations Dormitory D at the City of Gainesville Empowerment Center. The lowest/best evaluated bid meeting specifications (under the local preference ordinance) was submitted by George Burns Enterprise, Incorporated, with a bid amount of \$241,936.	
		Renovations of the Restroom at the Gainesville Empowerment Center (Dormitory D) were planned by the Facility Management Division for FY 2014. This project was requested to transform the existing restrooms using a design that is more conducive for use in an emergency shelter or homeless shelter. The new design allows for greater individual privacy and ADA accessibility.	
		<u>RECOMMENDATION</u>	The City Commission: 1) award the bid to George Burns Enterprises, Incorporated for Restroom Renovations at Dormitory D of the City of Gainesville Empowerment Center in the amount of

\$241,936; and 2) authorize the City Manager to execute the contract and any related documents, subject to approval by the City Attorney as to form and legality.
