Explanation: On August 21, 2014, the City Commission authorized the Human Resources/Organizational Development (HR/OD) Department to engage the services of an executive search firm in preparation of the April 2, 2015 retirement of City Auditor Brent Godshalk. Bob Murray and Associates a/k/a S. Renee Narloch & Associates conducted a search and presented a slate of highly qualified candidates to be considered at the February 5, 2015 City Commission meeting.

The City Commission will conduct interviews with the selected candidates on February 23, 2015 and February 24, 2015.
