Explanation: At their July 27, 2016 special meeting, the City Commission heard a presentation from staff on the current status of GRU's LEEP program as part of additional information the Commission had requested about GRU's proposed FY2017 budget. During citizen comment, the chair of the Utility Advisory Board (UAB), Darin Cook, expressed the Board's support for the LEEP program but that the Board thought the program could possibly be restructured to offer a better rate of return and to reach more low-income households. The Commission agreed that the program should be reviewed and voted to have a discussion about the program at an upcoming joint City Commission/UAB workshop.
