At some point, the General Policy Committee requested the City Attorney's Office report back on this topic. As this topic involves not just legal issues, but also administration/enforcement issues, the City Attorney's Office completed legal research and then met with Department of Doing and Code Enforcement staff to discuss whether conversion therapy is occurring in Gainesville, the scope of any potential prohibition, whether a prohibition would be effective and enforceable by the City and other administration and enforcement issues. The staff discussion and research identified some practical and legal issues. A memorandum from staff is provided in the back-up to assist the City Commission in its decision-making process on this topic. RECOMMENDATION The General Policy Committee discuss this matter.

to use pre-arrest diversion initiatives (Adult Civil Citations).

****ESTIMATED PRESENTATION TIME 15 MINUTES****

Explanation: Communities across the country are launching pre-arrest diversion initiatives designed to better address law enforcement's encounters with people who have challenges with drug use and mental health. These pre-arrest/pre-booking initiatives enable law enforcement officers, when appropriate, to divert eligible individuals away from the criminal justice system and into community-based behavioral health interventions and social services. In this way, law enforcement becomes a new and sizable pathway to treatment and social services.

> Simultaneously, federal, state and local governments and organizations are advocating for increased attention to and implementation of diversion initiatives that feature partnerships among police, treatment, and the community. The reasons for growth in these diversion initiatives are many: they promise reduced crime and recidivism, improved community/law enforcement relations, reduced burden on the justice system, restored lives, and cost savings.

What's been missing from the conversation about this emerging movement is a forum where national police, treatment and community leaders can join together.

Broadband Connectivity Sub-Committee requests to proceed with Broadband expansion Request for Proposals (B)

Explanation: The Gainesville City Commission established the Broadband Connectivity Subcommittee to the General Policy Committee to explore broadband availability, affordability, performance and development opportunities in our community. The initial meetings began in July of this year with three City Commissioners (Hayes-Santos, Ward, and Arreola), invitees from Alachua County IT and University of Florida representatives. Since then, the Subcommittee has reviewed a number of issues related to broadband delivery, with an emerging goal of "Expanding Affordable Internet in Gainesville". The sub-committee recognizes there are other areas of the county that are also underserved and have challenges in getting adequate broadband service. At the November 17th Broadband Connectivity Subcommittee meeting, the commissioners unanimously approved a motion to request that Alachua County partner with the City to further study how we may be able to improve broadband availability, affordability and access throughout Alachua County. The Subcommittee is in the process of recommending a Request for Proposals to conduct an analysis to determine how we can make Gainesville the "Most Connected City in America" and how we may achieve the following goals:

Primary Goals

- Lower prices and increased speeds for residents
- Lower prices and increased speeds for businesses
- Everyone has access to municipal network in designated areas Secondary Goals
- Lowest priced gigabit internet for residential service in the United

States

- Lowest priced internet for businesses in the United States
- Universal free service to all residents served

With consideration that areas outside of the city limits are in need of affordable broadband access, we would like to study the following areas to see if expanding our municipal internet service is a feasible option:

- GRU Service Area
- Urban Reserve with consideration for density

- Municipal areas within the county where GRUCom has infrastructure (Newberry, Hawthorne, Archer, High Springs, Waldo and Alachua

The expense for the feasibility study is estimated to be around \$140,000 and is expected to include feasibility cost estimates for several coverage options, financial feasibility and forecasting models for various market-based levels of service, a market analysis and a report of the study's findings.

Fiscal Note: The expected expense for the study as outlined is approximately \$140,000. Both GRU and General Government have budgeted \$20,000 each for a total of \$40,000 available funding.

RECOMMENDATION The General Policy Committee hear a report from the Broadband Sub-Committee and discuss options for moving forward.
