Subcommittee to Study Utility Advisory Board Code Provisions (B)

Explanation: On November 28, 2017, at a joint meeting of the City Commission and the Utility Advisory Board (UAB), both boards expressed interest in creating a subcommittee, consisting of two members from each board, to study the City Code provisions that govern the UAB and determine what Code changes, if any, should be made.
