DISCUSSION ITEMS

<u>160776.</u> Gainesville Annexation Strategy (B)

This is a request to hear an update from staff on annexation strategies.

Explanation: On August 24, 2017, the General Policy Committee (GPC) heard a presentation from staff and affected stakeholders in the unincorporated area, with a focus on the impact of the termination of the Fire Services Assistance Agreement (FSAA) and potential annexation strategies to provide relief to property owners who will see a reduction in service. Using spatial analysis and data analytics, staff presented the areas that would be most impacted by the termination of the FSAA. The GPC directed staff to explore opportunities to survey residents who will be most impacted by the termination of the FSAA to gauge interest in annexation.

On January 11, 2018, the GPC heard a presentation from staff with a recommendation to survey residents most impacted by the termination of the FSAA. The GPC was supportive of the staff recommendation to survey residents and directed staff to expand the boundary of the areas to survey. Staff will present information on an expanded survey area to include property east of I-75 in the northwest, west of Newnan's Lake on the eastside and south to Paynes Prairie.

In tandem with these efforts, residents of Sterling Place and Finley Woods Phase I neighborhoods have met with staff on multiple occasions and have requested that the City coordinate an annexation referendum for both neighborhoods. Additionally, staff will provide a brief update on progress being made in negotiating a Joint Planning Agreement to facilitate the seamless transition of services upon annexation and mitigate annexation challenges from Alachua County.

This is a request for the GPC to hear an update on recent activities, provide direction on an annexation strategy and removing this item from the referral list.

170453. Tom Petty Remembrance (B)

This is a request for General Policy Committee to hear a report on the survey results for the public engagement process in remembrance of Tom Petty.

Explanation: On October 2, 2017, the residents of Gainesville lost a beloved musician and hometown hero, Tom Petty. In the months since his passing, residents have requested that the City of Gainesville find a way to publicly honor Petty in a lasting and meaningful way.

November 9, 2017, the General Policy Committee discussed proposed processes for engaging the public in remembrance of Tom Petty. A draft outreach plan was presented showing action steps and a tentative timeline. To date, online and in-person surveys have been conducted and collected through various outreach methods. The Strategic Initiatives and Parks, Recreation and Cultural Affairs (PRCA) Departments have analyzed feedback and today will share viable options for the General Policy Committee's consideration, including: Renaming a city street;

Renaming a city park or facility;

Adding a statue to a city park or facility;

Hosting an annual concert or music festival;

Proclaiming his birthday, Oct. 20, as Tom Petty Day; or

Dedicating the month of October to his musical legacy and celebrating the local music culture.

The survey results provide feedback to the City in which further discussion can occur to see how the City Commission wishes to proceed. The proposed timeline is to have the selected project ready or in progress by October to commemorate the anniversary of Petty's passing.

Fiscal Note: No fiscal impact at this time.

<u>RECOMMENDATION</u> The General Policy Committee provide direction on how to commemorate Tom Petty.
