Amend Land Development Code to add Single Room Occupancy Residence (SROs) as a permitted use and add accompanying definition and use standards (B)

Petition PB-19-132 TCH. City of Gainesville. Text amendment to the Land Development Code to add Single Room Occupancy Residence as a nonresidential use in Article IV, along with applicable use standards added to Article V and definition added to Article II.

Explanation: This petition requests to amend the Land Development Code to add Single Room Occupancy Residences (SROs) to several non-residential zoning districts as a permitted use by right or by special use permit, along with applicable use standards and a definition. The amendments would include adding definitions to Article II, Section 30-2.1, adding the use to the permitted use table in Article IV Sections 30-4.12(Transects), 30-4.19 (Mixed Use and Nonresidential) and 30-4.23 (Special Districts), and adding a section in Article V, Division 1, concerning use standards to regulate the proposed new use.
