Explanation: On May 7, 2020, the City Commission unanimously approved a motion to hold a Strategic Planning Session. As a result of discussions on the agenda item, all Charter Officers have been invited to participate.

During this strategic planning meeting, the desired outcomes include:

Enhance the effectiveness of the Mayor and City Commission by providing a unifying vision, goals and annual work program, refine the teamwork and collaboration among the Mayor - City Commission and with City Manager, provide direction on critical strategic issues, develop a Policy Calendar for 2020, establish Vision 2035: a Vision Statement with defined, value-based principles that describe the preferred future in 15 years for the City of Gainesville, establish Goals for 2025: Define four to six goals with measurable objectives which become the major focus areas for the City of Gainesville, and create Plan 2020 - 2025: A plan to realize the vision, to enhance the mission and to achieve the goals with an analysis of major challenges.
