**How to Share Your Opinion.** Your opinion is important to the City Commission. There are multiple ways to give a public comment for the official meeting record. CA-3 200898. Public Comment Services Award Recommendation (B)

This item requests the City Commission authorize the City Clerk or designee to enter into a contract with Kearns & West, Inc. to provide public comment services for meetings of the City Commission and its advisory boards and committees.

Explanation: On November 23, 2020, the City of Gainesville solicited a Request for Proposal (CCLK-210011-MS) for services to facilitate live public comment during the City of Gainesville's public meetings. The services will provide teleconference technology that integrates with the City's physical and virtual meeting systems; and screening and moderation of

phone calls from members of the public participating in certain City meetings. The City will be able to request service as needed for regularly scheduled public board meetings and additional meetings as needed.

Two companies submitted responses. In non-ranked order, they were:

CherryRoad Technologies, Inc. Kearns & West, Inc.

Using the City's Professional and Other Services Evaluation Handbook, the team selected two companies to provide presentations in February 2021. Subsequent to the presentations, Kearns & West, Inc. was ranked first and CherryRoad Technologies, Inc. was ranked second. Staff recommend awarding the contract to Kearns & West, Inc.

Fiscal Note: The bid award amount proposed by Kearns & West, Inc. is \$195,175.00 annually.

Emergency funding under the CARES Act currently pays for this service. When these funds are no longer available to cover the expenditures, this will be a recurring General Fund expenditure until determined it is not needed.

RECOMMENDATION

The City Commission: 1) approve the selection of Kearns & West, Inc.; and 2) authorize the City Clerk to execute the contract subject to the approval of the City Attorney as to form and legality.

Richard Velez, as Personal Representative of the Estate of Juan Ramon Velez Caraballo v. City of Gainesville; Case No. 2020-CA-3302; Eighth Judicial Circuit, in and for Alachua County, Florida. (NB)

Explanation: On March 17, 2020, 77 year-old Juan Ramon Velez Caraballo was crossing Southwest 34th Street on foot when struck by a Regional Transit System bus traveling south. The incident occurred around 6:30 p.m. near the intersection of Southwest 24th Ave., which is an unsignalized

intersection. Mr. Velez Caraballo stepped from the curb near a Kwik Stop and crossed two lanes of traffic into the path of the bus which was traveling in the inside lane. There is no crosswalk at this location. The bus driver activated his horn and applied heavy braking but was unable to stop before impact. A passenger vehicle was traveling alongside the bus in the far right lane of Southwest 34th Street and was able to stop in time to avoid impact. Mr. Velez Caraballo was transported by ambulance to Shands Hospital where he later died as a result of his injuries.

The Estate of Mr. Velez Caraballo has brought suit for wrongful death, and a surviving son claims loss of consortium. The City Attorney's Office and Risk Management Department conducted a thorough evaluation and investigation of this lawsuit. Per the application of Florida's limited waiver of sovereign immunity contained in section 768.28, Florida Statutes, the City's liability and authority to settle claims such as this is limited to \$200,000 per person and \$300,000 per incident. A negotiated settlement was achieved, wherein representatives for the City agreed to recommend a settlement in the amount of \$165,000 subject to the approval of the City Commission of the City of Gainesville, and in exchange the Estate of Velez Caraballo and all surviving claimants will provide a full and complete Release to the City including waiving the pursuit of a claims bill to the Legislature. It is the recommendation of the City Attorney's Office and the Risk Management Department that the case be settled for that amount.

Fiscal Note: Funds are available in the City's General Insurance Fund.

#### RECOMMENDATION

The City Commission 1) approve the terms of the negotiated settlement agreement; and 2) authorize the City Attorney to settle the claim of Richard Velez arising from an accident that occurred on or about March 17, 2020.

#### CA-5 <u>180361.</u> Advanced Metering Infrastructure (AMI) (B)

Explanation: GRU staff presented this item at the January 14, 2021 Utility Advisory Board meeting and recommendations were unanimously approved.

Staff then presented the item at the January 21, 2021 City Commission meeting and requested that the Commission approve the Advanced Metering Infrastructure (AMI) project. The Commission asked staff to provide additional information and voted to continue the item to the February 4, 2021 meeting.

Staff returned to present the additional information at the February 4, 2021 City Commission meeting and the following recommendations were unanimously approved.

· Authorize the General Manager or his designee to negotiate and execute a Master Agreement with Itron for a term of 21 years that includes the purchase of the metering assets, network infrastructure,

software licenses, professional services to implement the project and the provision of ongoing software as a service for the hosting and ongoing maintenance of the software in a secure cloud. The Master Agreement set of documents includes SaaS, SOW, Order Document and MSA, which are all subject to approval by the City Attorney as to form and legality. (Previously Approved on 2/4/2021)

Authorize the General Manager or his designee to negotiate and execute an agreement with Aclara SGS for the installation of Smart Meters for the AMI solution. The agreement and SOW are subject to approval by the City Attorney as to form and legality. (Previously Approved on 2/4/2021)

Subsequent to receiving the requested approval, GRU realized that an additional contract that is necessary to complete the integration work was omitted from the previous recommendations, so staff returns to request that approval. This contract recommendation has no additional financial impact to the project, as it was included in the Cost Benefit Schedule 20210204 under System Integration (Util-Assist).

Util-Assist's professional services team guides electric, water and gas utilities through large-scale projects with end-to-end services and leading-edge technology. Util-Assist was selected as the lead consultant on the project in 2018 to assist with the ITN's and the contract negotiations. They have extensive knowledge into how we conduct business and have worked with GRU on other system implementations. It would be integral to have Util-Assist continue through the project with familiar resources and expertise. With their extensive industry knowledge, both utilities and AMI, coupled with their familiarity with GRU operations, GRU staff, and the intricacies of GRU's agreements with Itron and Aclara, they are uniquely positioned to assist GRU with its AMI implementation.

Fiscal Note: No additional financial impact, as the costs were included in the fiscal note presented on February 4, 2021.

RECOMMENDATION

Authorize the General Manager or his designee to negotiate and execute an agreement with Util-Assist to provide integration and project support for the AMI solution, subject to approval by the City Attorney as to form and legality.

#### **CA-6** 180555.

Request for the City Commission to Allocate Funds from the Wild Spaces & Public Places Unappropriated Fund Balance for a List of Projects that will Kick off in 2021 and Approve Forest Park as a Wild Spaces & Public Places Project (B)

Explanation: In November 2012, the City Commission approved the Parks,
Recreation and Cultural Affairs Vision 2020 Master Plan. During 2013 to
2015, citizens and staff worked together on the development of a specific
list of projects referenced in the Master Plan. On February 18, 2016, the
City Commission approved a list of 99 Wild Spaces & Public Places
(WSPP) potential projects and the prioritized list of projects with cost
estimates. The Voter Referendum on Wild Spaces and Public Places
passed on November 8, 2016 and the collection of the one-half cent
sales tax began on January 1, 2017, and will continue through December
31, 2024. It is expected to generate over \$60M in revenue to the City.

At the time of passage, Forest Park was owned and managed by Alachua County and was not included on the list of 99 WSPP potential projects. In November 2017, the park was transferred to the City. According to ParkServe there are 2,741 people who live within a 10 minute walk of Forest Park. This request is to formally add Forest Park to the list of 99 potential WSPP projects.

At the General Policy Committee meeting on January 14, 2021, the Committee heard a presentation from staff on proposed WSPP projects to kick off in 2021, as outlined in the "WSPP Projects to Kick-off in 2021" spreadsheet. A follow up discussion on an outdoor event center in Gainesville, Tom Petty Park and Glen Springs took place at the General Policy Committee meeting on February 25, 2021.

Strategic Connection: This item is connected to Goal 3: A Great Place to Live and Experience and is a high priority.

Fiscal Note: The Wild Spaces Public Places sales tax was approved by voters for eight years and is expected to generate over \$60M in revenue to the City. This agenda item requests approval for spending \$14,880,000.

Some projects will have associated operation and maintenance expenses. These expenses will be further defined during project planning and design and will be brought before the City Commission during scheduled WSPP project update meetings and construction bid awards.

#### RECOMMENDATION

The City Commission approve the addition of Forest Park to the list of potential WSPP projects and approve the allocation of \$14,880,000 of Wild Spaces & Public Places revenues towards projects as defined within the "WSPP Projects to Kick-off in 2021" spreadsheet.

## CA-7 <u>200843.</u> Application for Disability Retirement Kenneth Glenn Corbett (B)

This item request approval of the Disability Retirement application of Power Plant Mechanic Journeyman for Energy Supply.

Explanation: A meeting of the Disability Review Committee was conducted on Tuesday, February 9, 2021 to review the application for disability retirement of Power Plant Mechanic Journeyman. His relevant medical information was reviewed by the Plan's third party administrator and they

determined that Mr. Corbett is unable to perform the job duties as a Power Plant Mechanic Journeyman for the City of Gainesville. This is the standard for approving a disability retirement under the General Employee's Pension Plan. In reviewing the application and supporting information from his physician, it is the recommendation of the Disability Review Committee that the Board of Trustees of the Plan approves the application.

Fiscal Note: Mr. Corbett's out-of-line-of duty pension benefit is \$1,570.98 before
Social Security Offsets and will be paid out of the City of Gainesville
Employee's Pension Plan. The benefit is gross of any offsets associated
with collateral income as required by the Plan. If Mr. Corbett should
receive collateral employer provided benefit income, those offsets will be
taken from the monthly benefit.

RECOMMENDATION

The Board of Trustees of the City of Gainesville Employee's Pension Plan approve the disability retirement of Kenneth Glenn Corbett retro-active to February 1, 2021.

#### CA-8 <u>200844.</u> Human Resources Policy L-3: Paid Time Off Leave System (B)

Explanation: As a result of collective bargaining, the City and its two law enforcement bargaining units (Fraternal Order of Police and Police Benevolent Association) agreed to and implemented a voluntary transition from the legacy Vacation/Sick leave system to the Paid Time Off (PTO) leave system. Part of those provisions carried forward the officers' option of selling back up to 70 hours of PTO annually.

In order that the policy covering command staff align with the contractual provisions covering rank and file, staff recommends permitting the same 70 hour maximum annual sell back option for non-represented ranks (e.g. Captain, Chief Inspector, Assistant Chief, Chief). In addition to equity across ranks, this change would remove any leave system related disincentive for promoting to a command staff rank.

In addition, current policy provides that annual sell back of PTO is limited to the pay period nearest the employee's anniversary date. The Police Benevolent Association collective bargaining agreement permits sell back at any one time during the fiscal year. The proposed changes include a modification that would permit any PTO participant the ability to sell back leave one time during the fiscal year.

Fiscal Note: The maximum incremental cost associated with the proposed change is \$13,590 per year, and assumes all eligible command staff members sell back the maximum 70 hours.

#### CA-9 **200867.** Request for Proposal (RFP) Broadband Business Plan Strategy (B)

Explanation: On July 16, 2020, the City Commission requested city staff to look at the previous broadband feasibility study and see how to make the city broadband project more achievable. During the discussion, the City Commission wanted to address the issues with low-quality broadband, costs of broadband, and the digital divide.

To that end, staff prepared a Request for Proposal (RFP) that was released by the City's Purchasing Division on 11/04/2020. A diverse staff evaluation team reviewed proposals from two (2) entities submitted consistent with the City's procurement regimen. The number one ranked firm Magellan Advisors, LLC has prior experience working on similar projects across Florida. The City of Lakeland, FL, City of Clermont, FL, and seven other Florida cities and towns. Magellan Advisors, LLC also had an engaging and mature approach to Digital Inclusion Strategy. It includes surveying the local population to determine issues and engaging city leaders and stakeholders to identify new opportunities and programs to build and implement a Broad digital inclusion plan across the City. Staff ranked the two firms:

- 1) Magellan Advisors, LLC
- 2) Tilson

Fiscal Note: The bid award amount proposed by Magellan Advisors, LLC is \$145,400. Funding of \$49,886.52 has been identified from fund 990-9901 (Broadband Feasibility Study funding) and \$95,513.48 has been identified from fund 511-M182 (Broadband Costs).

#### RECOMMENDATION

The City Commission: 1) approve the selection of Magellan Advisors, LLC 2) authorize the City Manager or designee to negotiate a contract and any related documents with Magellan Advisors. Subject to approval from the City Attorney as to form and legality; and, 3) return to the City Commission for final review and approval of the contract.

#### **CA-11** 200890. Request for Proposal (RFP) City of Gainesville Disparity Study (B)

This item involves a request for the City Commission to approve the staff ranking of proposals relating to the City of Gainesville's Disparity Study. AGENDA UPDATE - ADDED ITEM

Explanation: The City of Gainesville is seeking to ensure equity in its procurement. The City currently operates a small business program that includes outreach, training, education, direct solicitation of bids, and price preferences for certified small businesses. The City's Procurement department released a Request for Proposal (RFP) on December 3, 2020, with the intent to select a qualified firm to provide professional services in conducting a disparity study.

The selected firm will be responsible for assisting the City with assessing whether there are disparities between the utilization of minority- and women-owned businesses (MBEs and WBEs) in City procurement and the availability of MBE/WBEs even with the small business program in place.

Fiscal Note: Funds were reserved from the Office of Equity and Inclusion Budget in the amount of \$300,000. The total cost for the study is \$298,550

BD-1 200865. Request for Proposal Staff Ranking City of Gainesville, FL-Affordable **Housing Property Donation Pilot Program (B)** 

This item involves a request for the City Commission to approve staff's ranking and recommendation for a proposal associated with the City of Gainesville, FL-Affordable Housing Property Donation Pilot Program.

Explanation: On November 16, 2020, the City's Procurement Division issued a Request for Proposal (RFP) with the intent to select a nonprofit affordable housing developer to receive a donation of twelve (12) City owned lots and develop those lots with affordable owner-occupied homes for income eligible households.

> Generally, the lots are located in the Duval Heights Area of Northeast Gainesville, along NE 9th Avenue, near NE 16th Terrace and NE 17th Street. The RFP requires the nonprofit organization to sell the homes and move the households in, within two (2) years of receiving the lots.

Only one (1) organization, Alachua Habitat for Humanity, Inc. (AHFH), submitted a response to the City by the RFP required date of January 14, 2021. The Procurement Division reviewed the proposal and determined that it was consistent with the City's procurement procedures. Then a staff evaluation team consisting of representatives from the Housing and Community Development (HCD) Division, the Office of Equity and Inclusion, the Public Works Department, and the Department of Sustainable Development reviewed, evaluated, and discussed the proposal. Based on that evaluation, the evaluation team determined that the proposal meets the City's needs and requirements as described in the RFP; and that the proposer has the experience and resources to

implement the proposal. The evaluation team recommends that the City begin negotiations with AHFH to donate the subject properties to AHFH for the development and sale of affordable housing to income eligible households.

As part of this project, the City will install a new road. Currently, NE 9th Avenue, between NE 16th Terrace and NE 17th Drive is not built, although the City does own the right-of-way. That segment of road is needed to provide convenient access to at least five (5) of the subject properties. In support of this project, the City has budgeted \$240,000 in Gainesville Community Reinvestment Agency Department (GCRAD) funds to construct enough of that portion of NE 9th Avenue to provide the needed access. Due to the addition of new impervious surface associated with the new road, the City will be required to construct a new stormwater management facility to prevent flooding. Originally, the City hoped to purchase a vacant privately owned lot located nearby. However, the City and the property owner were not able to reach an agreement. Therefore, the City will move the location of the stormwater management facility to one or two of the lots originally planned to be donated to the developer. As a result, the number of donated lots will be reduced based on the property needed for the stormwater facility (attached for reference is a map of the lots that may be impacted by the relocation of the stormwater facility). Public Works staff will coordinate the development of the road construction project with the development of the new homes.

In addition to donating the lots and constructing the road for no cost to AHFH, the City is reserving funding that will be structured as a developer/home buyer subsidy to ensure that the lots will be affordable to income eligible first-time home buyers.

#### Strategic Connection:

This item is connected to Goal 3: A Great Place to Live and Experience in the City's Strategic Plan and is a high priority item.

Fiscal Note: Funds have been reserved from the GCRA budget in the amount of \$240,000 to construct a portion of NE 9th Avenue. Additionally, funds have been identified from the proposed ConnectFree budget in the amount of \$228,000 and from the SHIP budget in the amount of \$47,000 to make available homebuyer and developer subsidies.

#### RECOMMENDATION

The City Commission: 1) approve staff finding that the proposal meets the City's needs and requirements as described in the Request for Proposals; and that the proposer has the experience and resources to implement the proposal; 2) authorize the City Manager or designee to negotiate a contract with Alachua Habitat for Humanity for the development and sale of affordable housing to income eligible households, subject to approval from the City Attorney as to form and legality; and 3) authorize the City Manager or designee to execute the

contract and any related documents, subject to approval from the City Attorney as to form and legality.

#### BD-2 200870. Approval of Surplus Property List (B)

This item involves City Commission approval of a listing of proposed surplus and escheated properties for future disposition.

Explanation: On May 21, 2020 the City revised the previously adopted Real Property Policies under Resolution No. 191223. The policy states that the City Commission is tasked with reviewing a list of proposed surplus and escheated properties and determining which of the properties are surplus and approved for donation so that disposition may take place.

The City's policy dictates that the foremost goal of disposition of these properties shall support the City's housing goals, including the provision of permanent affordable housing, neighborhood enhancement and stabilization, infill development, and mitigation of the impacts on vulnerable communities from gentrification and displacement.

The Department of Sustainable Development will determine the properties that are suitable for development as single-family or multi-family/mixed-use affordable housing based on such factors as a lot's zoning designation, size, shape, configuration, and known environmental issues.

Escheated properties that are deemed surplus by the Commission, per the mechanism in the policy, are donated to nonprofit housing organizations (NHO's) that conduct business in the City of Gainesville and are capable of constructing permanent housing. A reverter clause is included in the deed language so that if homes are not constructed within the designated time period (usually two years), then the City regains all rights of possession of the property.

Currently, Alachua Habitat for Humanity, Inc. holds deeds for two City properties with expired reverter clauses. One property (TP# 11235-010-000) is on target for being granted a Certificate of Occupancy in approximately one month. Construction on the other property (TP# 11317-000-000) is slated to begin in 2022. Staff asks for a two year

extension for these projects though clearly the former will be completed before the new expiration, if granted.

In general, when disposition occurs the property is sold "As-Is" and all closing costs, including due diligence, are paid by the Buyer.

When multi-family/mixed-use property is disposed of in the affordable housing context, a restriction is placed so that a certain amount or percentage of housing development on the property shall be permanent affordable housing and ensured to be permanently affordable under the condition of legal mechanisms as determined and approved by the City Attorney's Office.

Fiscal Note: There is no known fiscal note associated with this item at this time.

#### RECOMMENDATION

The City Commission: 1) approve the Resolution declaring the City property, as further described in Exhibits A and B, as surplus; and 2) approve donation of the escheated parcels to NHO's; and 3) extend the expired reverter clause for two years on two Alachua Habitat for Humanity, Inc. parcels; and 4) authorize the Mayor to execute, and the Clerk to attest the Resolution, subject to review and approval of the City Attorney's Office as to form and legality.

> Every application that requires board approval, including future land use map changes, re-zonings, special use permits, as well as subdivisions and development plans which do not require board approval, must first hold a neighborhood workshop and shall include in the application a written record of such meeting.

> The proposed amendments would require a more robust public participation process which would not only include additional requirements for neighborhood workshops, but would also require submittal of a Public Participation Report documenting the results of the public participation effort.

> Proposed changes were considered at the October 22, 2020, January 4, 2021, and January 28, 2021 Plan Board meetings. The Board approved the proposed changes unanimously along with a proposed revision to Division 9 to add mandatory review of Major Development Plans by the City's Development Review Board. These plans are currently being reviewed administratively by staff in various departments in the City.

ORDINANCES, 2ND READING - ROLL CALL REQUIRED (SR)

An ordinance of the City of Gainesville, Florida, amending Ordinance No. 080565 commonly known as "Alachua Health Services Stillpoint" Planned Development located in the vicinity of 2730 NW 39th Avenue to allow for a 30 bed assisted living facility (ALF) and other permitted uses with certain conditions, as more specifically described in this ordinance; providing directions to the City Manager; providing a severability clause; providing a repealing clause; and providing an immediate effective date.

#### Explanation: STAFF REPORT

This ordinance will amend an existing Planned Development (PD) known as the Alachua Health Services Stillpoint, by amending Ordinance No. 080565 which was adopted by the City in 2009. Adoption of the ordinance in 2009 allowed for the medical office uses that exist there today which include services from acupuncturists, massage therapists, herbalists, psychotherapists, physical therapists, and chiropractic. This amendment will allow for the property to be used as a 30-bed assisted living facility (ALF) with two phases of development; medical and dental offices; or research development and testing facilities. Phase 1 of the ALF development includes using existing space to accommodate 18 to 20 beds, and Phase 2 would add approximately 1,500 sq ft of new building area to accommodate 8-10 beds. The size of the facility will be governed by State of Florida guidelines for ALFs. The total building area allowed would increase from 3.505 sq ft to 5.000 sq ft. The intent is to provide an affordable living arrangement for elderly residents who receive federal government assistance.

At a public hearing on October 22, 2020, the City Plan Board voted to recommend approval of this Planned Development amendment. This ordinance requires two readings and will become effective immediately upon adoption.

<u>RECOMMENDATION</u> The City Commission adopt the proposed ordinance.

#### AGENDA UPDATE - CHANGED TEXT FILE

Explanation: The City Commission has previously expressed a desire to see city construction projects provide students enrolled in apprenticeship programs associated with the construction trades with the opportunity to gain valuable on-the-job training performing construction work. This experience will not only allow apprentices to hone their classroom-taught work skills, making them more employable in jobs that pay, in many instances, wages well above \$15/hour, it will also serve to support area apprenticeship programs and help increase the pool of available workers in an industry that is considered essential to the overall health of the local economy.

Additionally, the City Commission has previously expressed a desire to see city construction projects give local disadvantaged workers the opportunity to obtain useful work experience as well as employment in the construction industry. Gainful employment in the construction industry will not only enhance the work skills of disadvantaged workers, making them more employable in jobs that pay, in many instances, wages exceeding \$15/hour, it will also serve to increase the pool of available workers in an industry that is considered essential to the overall health of the local economy.

Additional legislative history regarding this ordinance can be found in Legistar legislative files numbered 180402, 200157 and 200585.

This ordinance requires two hearings and will become effective immediately; however, to allow time for education and implementation, it will apply to solicitations for construction projects issued by the City on or after July 1, 2021.

Strategic Connection: This item is connected to Goal 4: Resilient Local Economy in the City's Strategic Plan.

Fiscal Note: It is unknown at this time whether, or by how much, this will increase the price of bids received by the City for construction projects.
